Five people commented on a number of topics including the ceramics program, the math conference held at OCC and changes within the College.

Chancellor's Report

Chancellor Meyer congratulated the Orchard Ridge Campus on their certificate of recognition and special environmental sensitivity award from the City of Farmington Hills Beautification Commission. He also recognized Dr. Pam Jackson (OR math faculty) for being named National Association of Professional Women's (NAPW) VIP Woman of the Year.

- Bob Montgomery, Vice Chancellor for IT, and Sharon Miller, Vice Chancellor of External Affairs, provided the Board
 an update on broadcasting their meetings. OCC is the only community college in the state providing cable public
 access channels DVD copies of board meetings.
- Dr. Gordon May, AH President, introduced Thomas Dayfield, a new AH public safety officer.
- Chancellor Meyer introduced the Interim Vice Chancellor of Administrative Services Richard Kolz who will oversee
 the College's physical assets and public safety, and Charles Thomas, Interim Vice Chancellor of Business and Finance,
 who will be responsible for the College's financial assets.
