1. LUIS on WSUnet --

A draft task list for implementing LUIS on WSUnet was discussed, adding and revising tasks, assigning staff, and assigning target completion dates.

Al McCord and Louise Bugg will arrange a meeting between CSC and Library staff March 25th to work on several of the tasks.

It was recommended by CSC staff that a SIM3270 software license be obtained for the IBM4381, to enable MERIT users to access LUIS directly rather than via the IBM3081.

The task list will be typed and distributed to all involved.

2. NOTIS implementation --

Becky installed the 3174 compatibility "kit" in an Interlynx protocol converter, enabling the Circ printing to function for NOTIS Circulation training.

3. Programmer applicants --

Copies of candidates' applications for the programmer's position were given to Kelly and Rick for their review. Jim Williams will schedule the interviews after he returns from vacation on March 23.

4. Disk drive --

The used 3380 B04 disk drive ordered is expected to be delivered soon. Louise will advise all parties when there is a delivery date. It must be accepted for IBM maintenance before it is installed.

5. Software for IBM4381 --

Carolyn Kaye discovered no ACF2 software license was ever obtained for the IBM4381. It will cost about \$25,000. She will send info to Louise for the Library to pursue.

6. Multi-dropping lines --

Jerry K. is testing multi-dropping more than one IBM controller on a phone line. Two 3174's in Purdy are now on one phone line. Next to be multi-dropped are (1) Law Library and Law School; (2) Science Library and Chemistry. Louise will send Jerry K. a list of the Library's Codex modem serial numbers, so there is minimal confusion when they are re-located.

7. DALNET planning --

Draft schedules were distributed for Beaumont and Botsford Hospitals, with an overall schedule that included Oakland and WCCC as well.

There should be no problem getting PROFS ID's for these libraries, identifying them as external customers of the Library System.

IBM's Joe Moody is up-dating the IBM Token Ring Configuration for a 3-station ring. When he gets info to the Library, it will be forwarded to Scott Merryfield for his review. IBM does not recommend modems or other equipment needed to hook the ring up to a phone line. The ring configuration needs to accommodate system printing.

WCCC is sending Louise a manual for their Wyse 60 terminals, which are supposed to emulate Wyse 50's. They have no modem to use, however, to test this terminal on MERIT. Rick will get info re. using SCP's as "controllers" at the WCCC library sites. There is a long turn-around on SCP's from U of M, since they customize these boxes. Kelly will also check with Pat Gossman who is working with the WCCC Computing Center, to see if SCP's would fit into their evolving computing network.

The next meeting is scheduled for April 1st, at 10:00 a.m.
