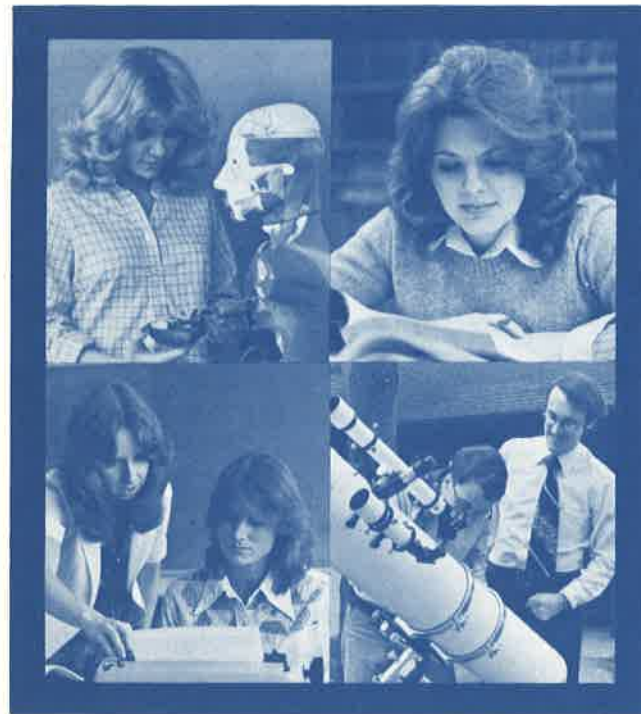

In a few weeks we will be telephoning to ask for your participation in the "Salary Sharing" program. The volunteer caller will be a member of the "Phone-A-Visit" team.

You will be asked to help Michigan Christian College continue to serve young people and the church. We sincerely hope your response can be positive.

You can now re-direct 20% of your Michigan Income Tax dollars to the support of Christian education. The Michigan Income Tax Credit can be used to support any of the 97 colleges in Michigan. Unless you use *your* tax credits by supporting MCC they will be lost to Christian education.

How can these tax dollars be diverted to Michigan Christian College? You can give up to \$200 as an individual or \$400 as a married couple per year to MCC and, generally, take an amount equal to one-half of the gift as a direct credit against your Michigan Income Tax. For example, as a married couple, let's assume your Michigan Income Tax liability for the year to be \$600. You are limited to 20% or \$120 as a credit against your state income tax. Thus, your tax liability is reduced to \$480. To accomplish this, you would give MCC \$240 during the year and claim half, or \$120, as a credit against your tax when you file your

Michigan Income Tax return. If payroll deductions have already fully paid your taxes, the state will refund you \$120 upon the filing of your tax return.

Another way to look at it: Every Michigan taxpayer who contributes to higher education is allowed 20% of his or her state income tax liability as a tax credit. The maximum credit is \$100 per person or \$200 for a married couple. In a sense, your tax credits can be used to pay half your gift to MCC. This means that for each \$1 gift to MCC, you purchase \$2 worth of Christian education by taking advantage of the tax credit.

Since Michigan is encouraging us to support Christian education, please resolve that you will divert every tax dollar possible to support Michigan Christian College. *In order to qualify for any of the state income tax credits, you must make your contribution payment prior to December 31 of the taxable year.*
