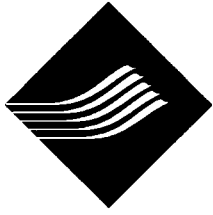

The following report contains data related to: 1) the number of student credit hours; 2) total student headcount; and 3) the number of credits per student. Please note the section of this report which indicates high and low enrollment figures for First Day of Session data over the past ten years.

All individual campus Student Credit Hours and Headcounts can be found in the Credits per Student tables.

- College-wide Student Credit Hours (221,944.50) **decreased** 9.8% when compared with the same time period last year. Over the five-year period (2009 to 2013), total Student Credit Hours **decreased** by 1.1%.
- Student Headcount (26,038) at the college-wide level **decreased** by 9.1% from last year. Over the five-year period, headcount **decreased** by 1.0%.
- College-wide Credit Hours per Student (8.52) have **decreased** 0.9% since last year. Over the five-year period, this figure **decreased** by 0.2%.

Credit hours, headcount, and credit hours per student all decreased when compared to 1-year and 5-year periods.

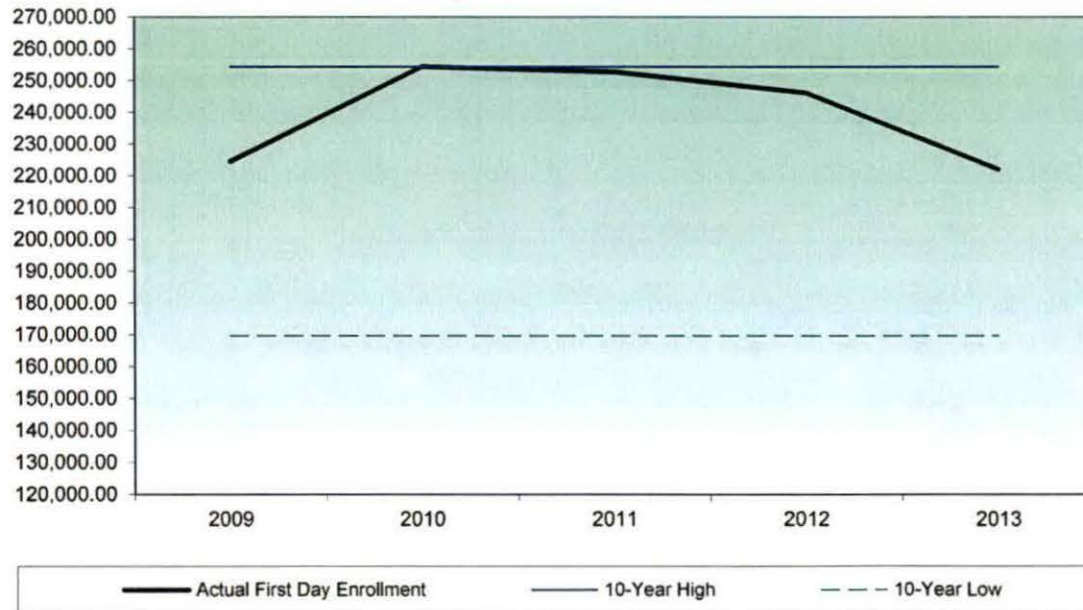

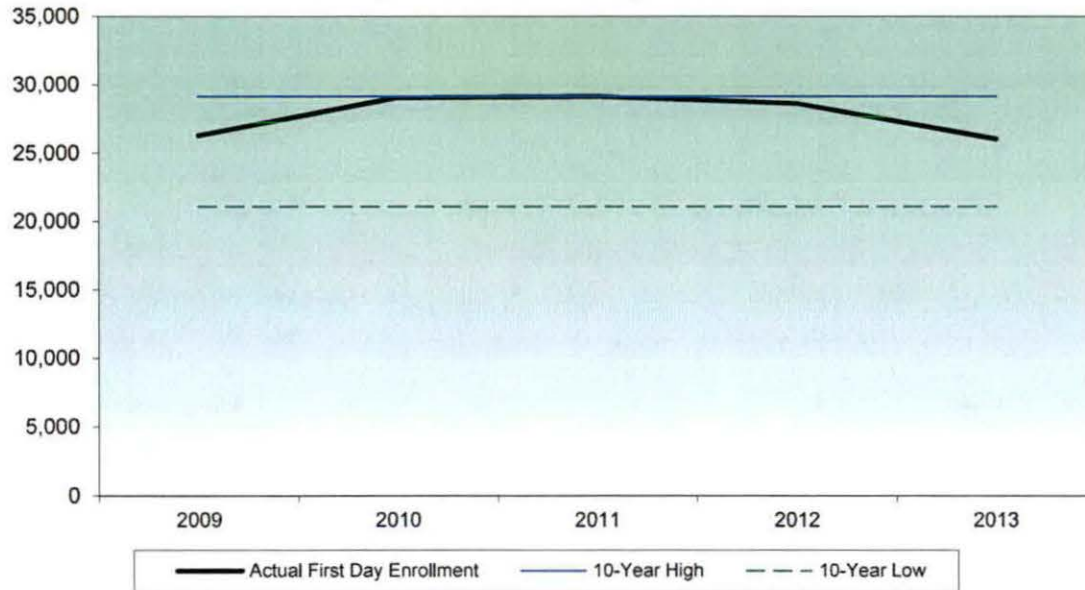

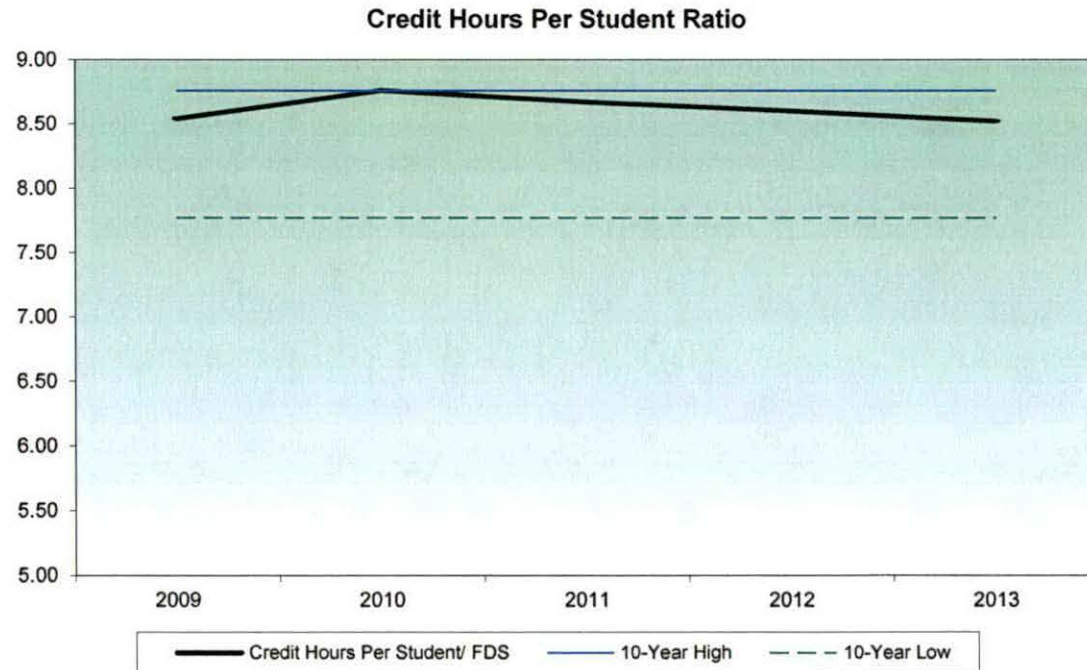

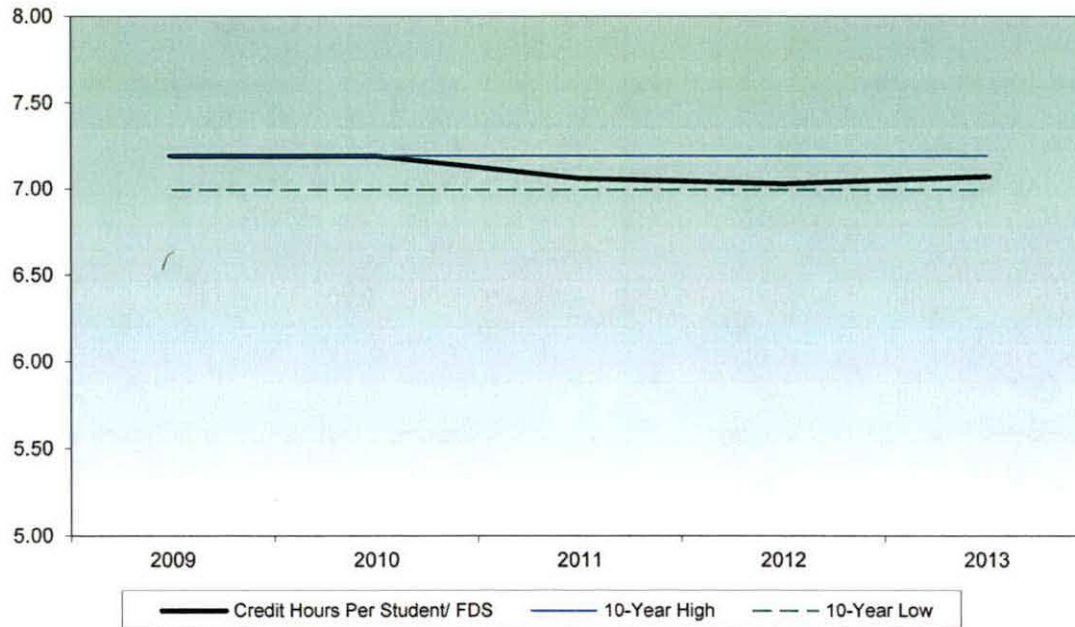

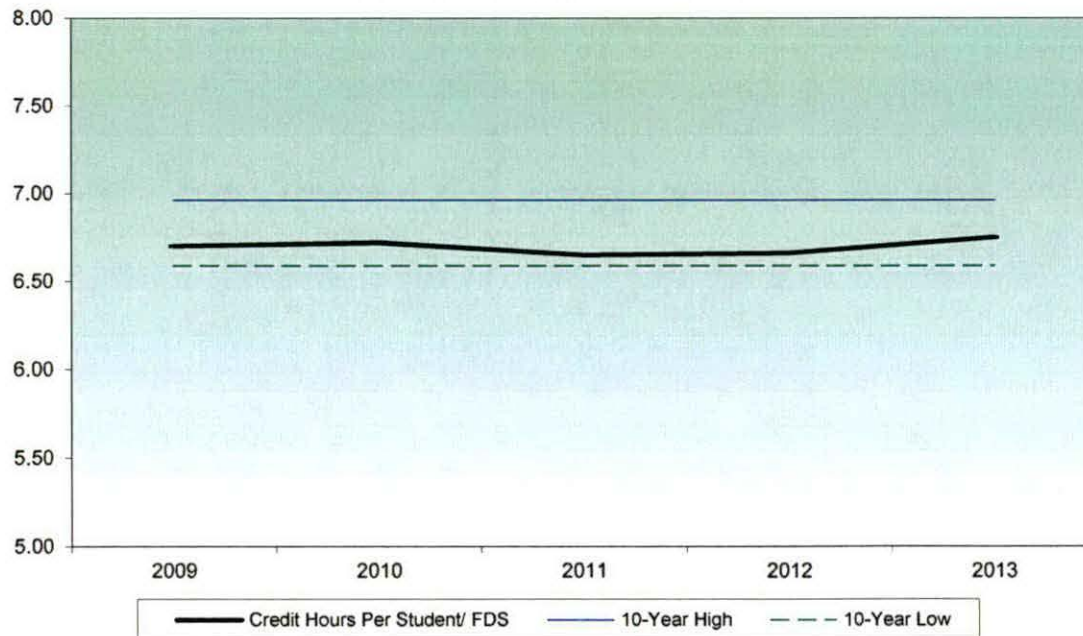

The following report contains data related to: 1) the number of student credit hours; 2) total student headcount; and 3) the number of credits per student. Institutional Research has added a section to the One-Tenth Day Report that compares College-Wide One-Tenth Day enrollment figures with First Day of Session figures for the same term.

All individual campus Student Credit Hours and Headcounts can be found in the Credits per Student tables.

- College-Wide Student Credit Hours (226,278.50) **decreased** by 3.7% when compared to the One-Tenth Day last year (Fall 2012). Over the five-year period (2009 to 2013), total Student Credit Hours **decreased** 7.3%.
- College-Wide Student Headcount (26,618) **decreased** 3.2% from last year, and **decreased** 5.4% when compared to Fall 2009.
- College-Wide Credit Hours per Student (8.50) **decreased** 0.5% since last year, and has **decreased** 2.1% from Fall 2009.

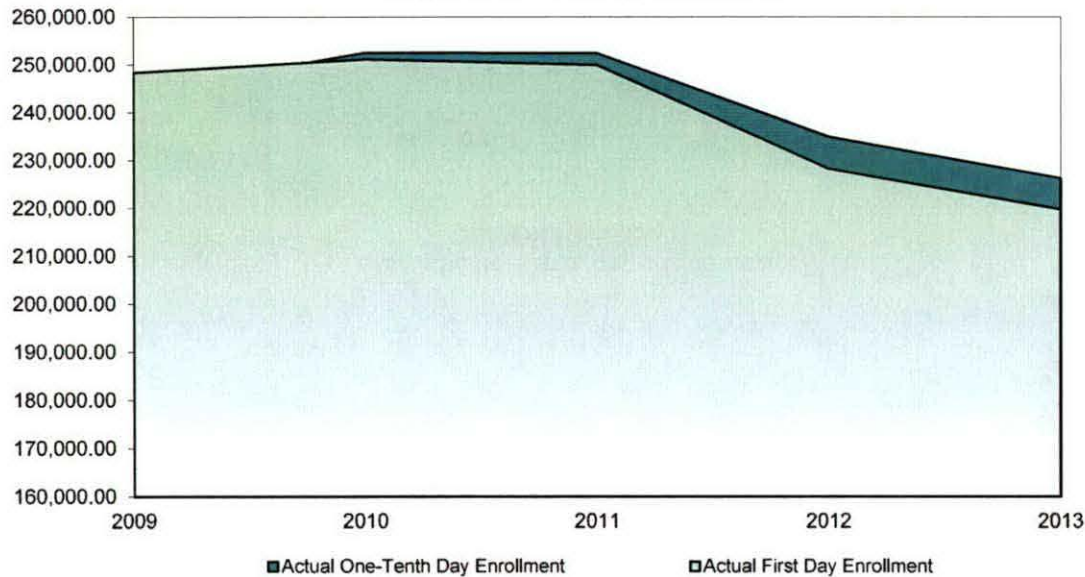

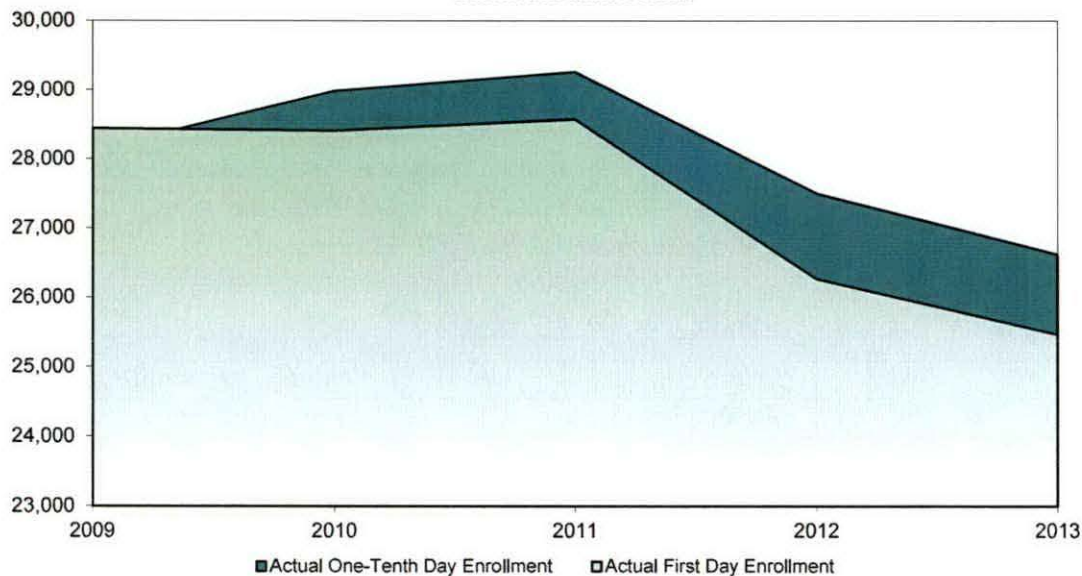

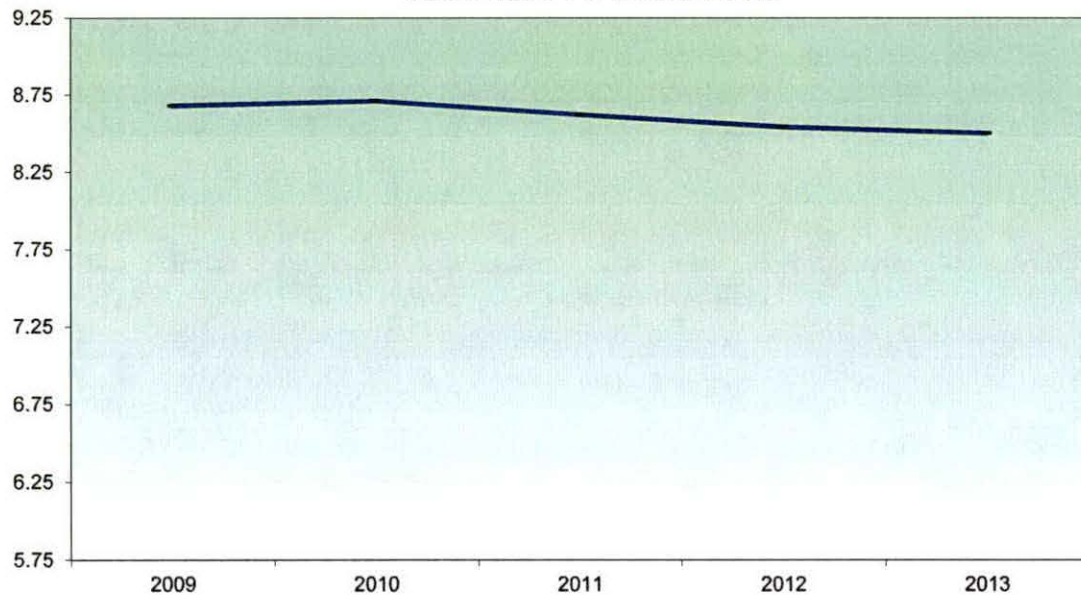

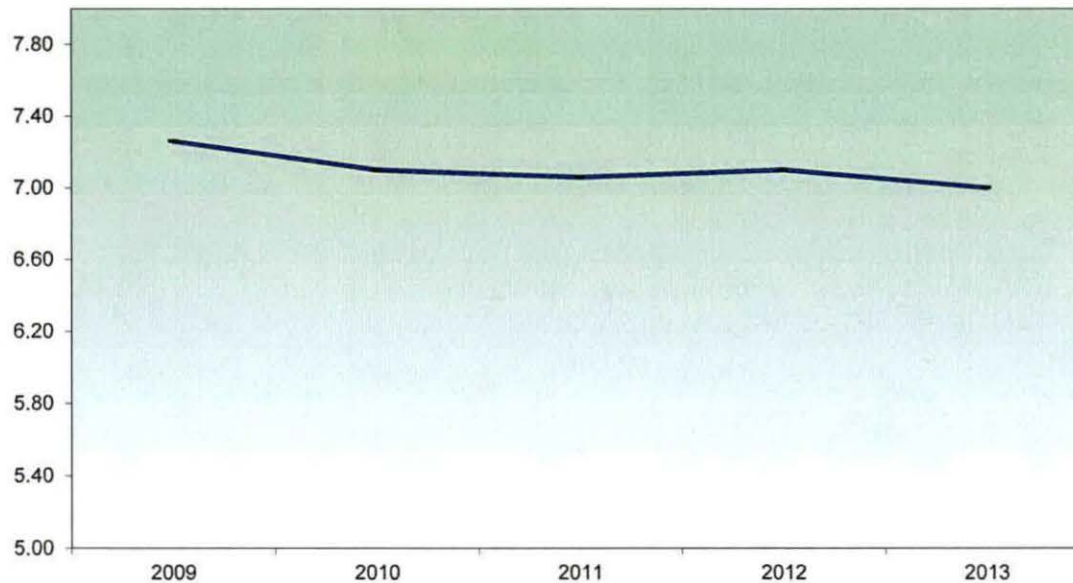

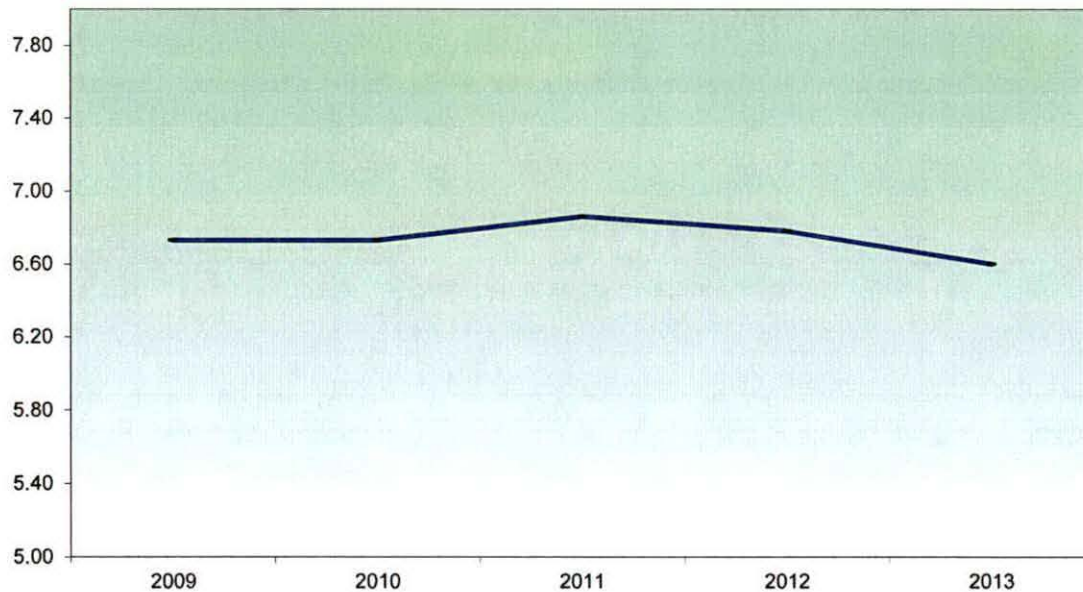

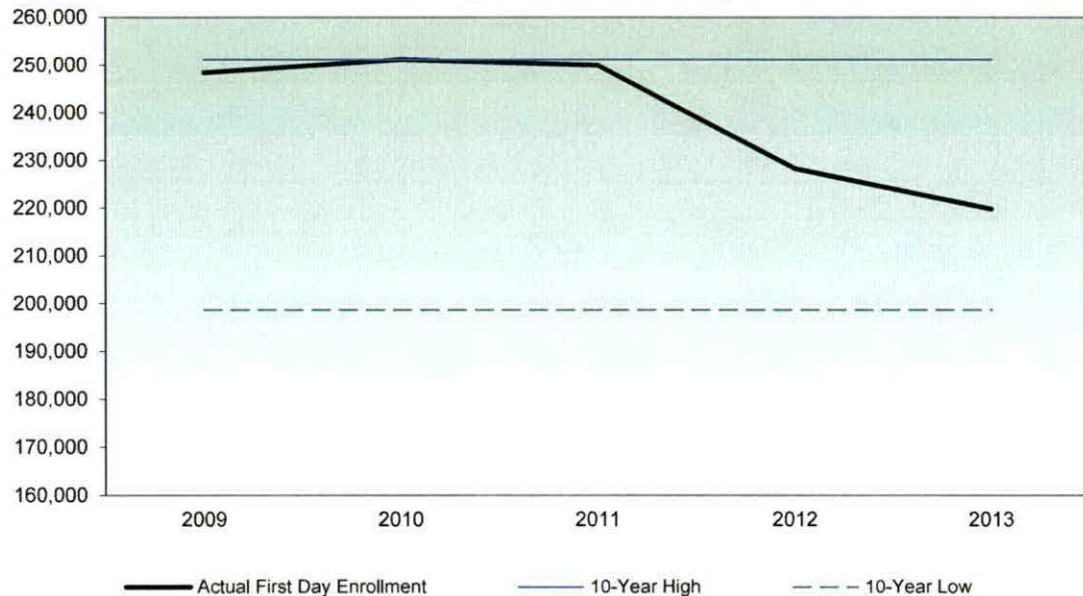

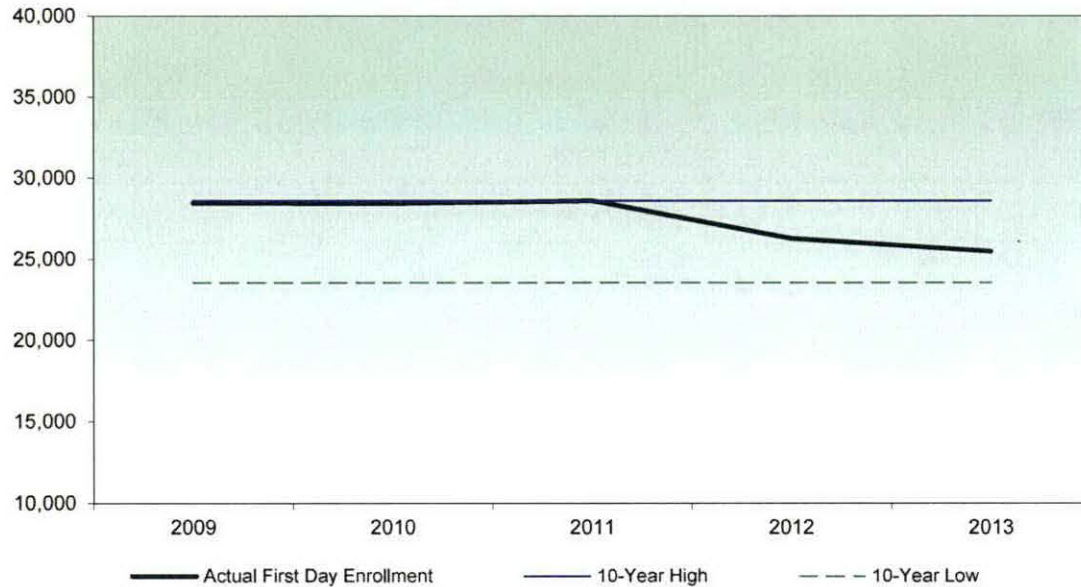

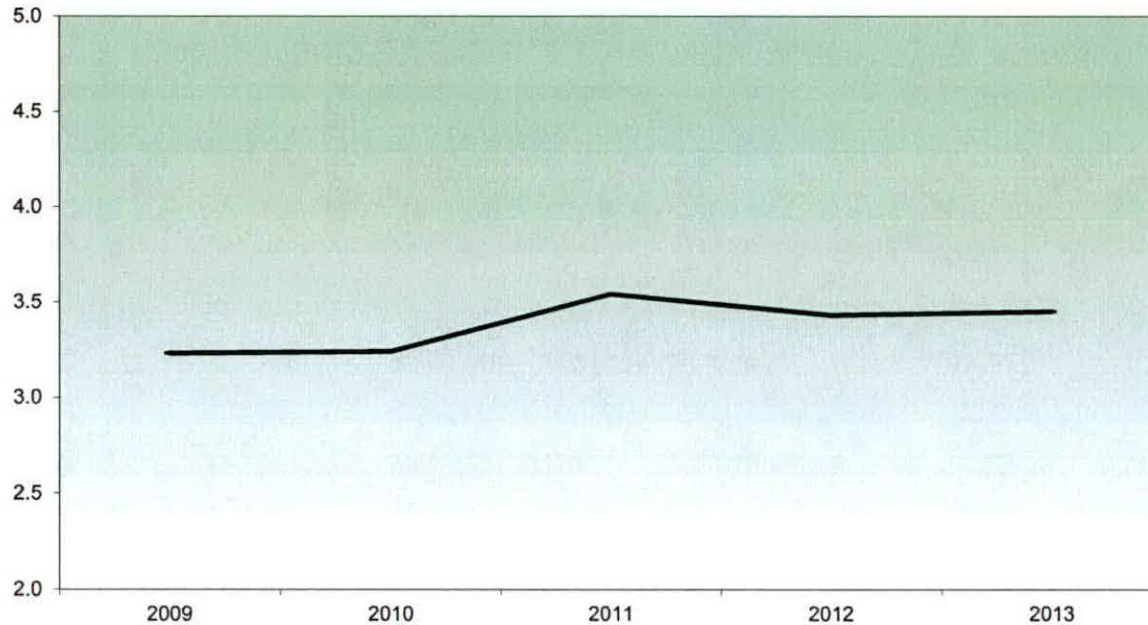

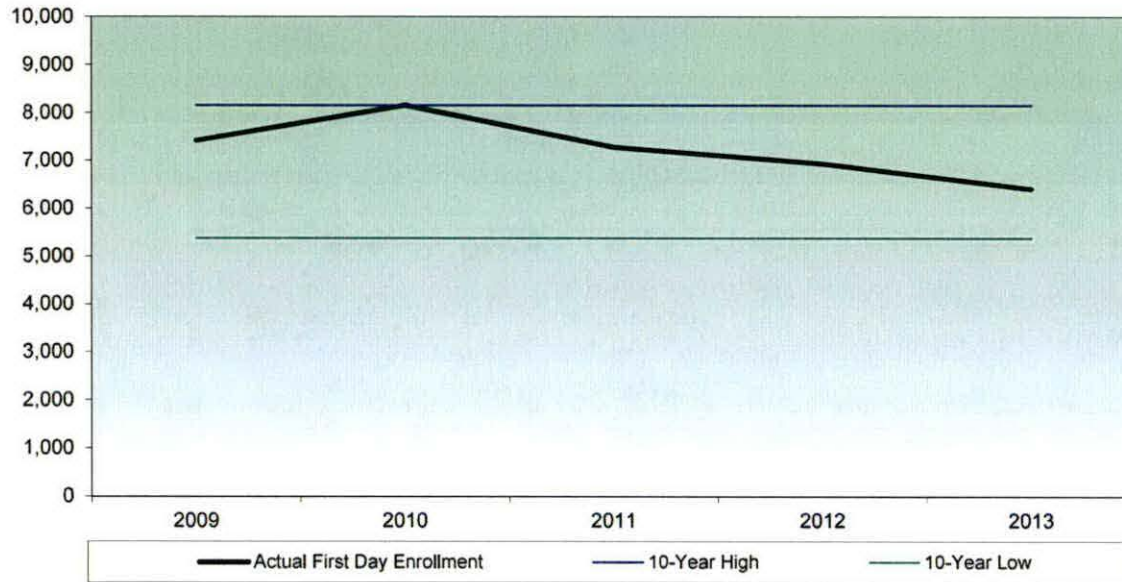

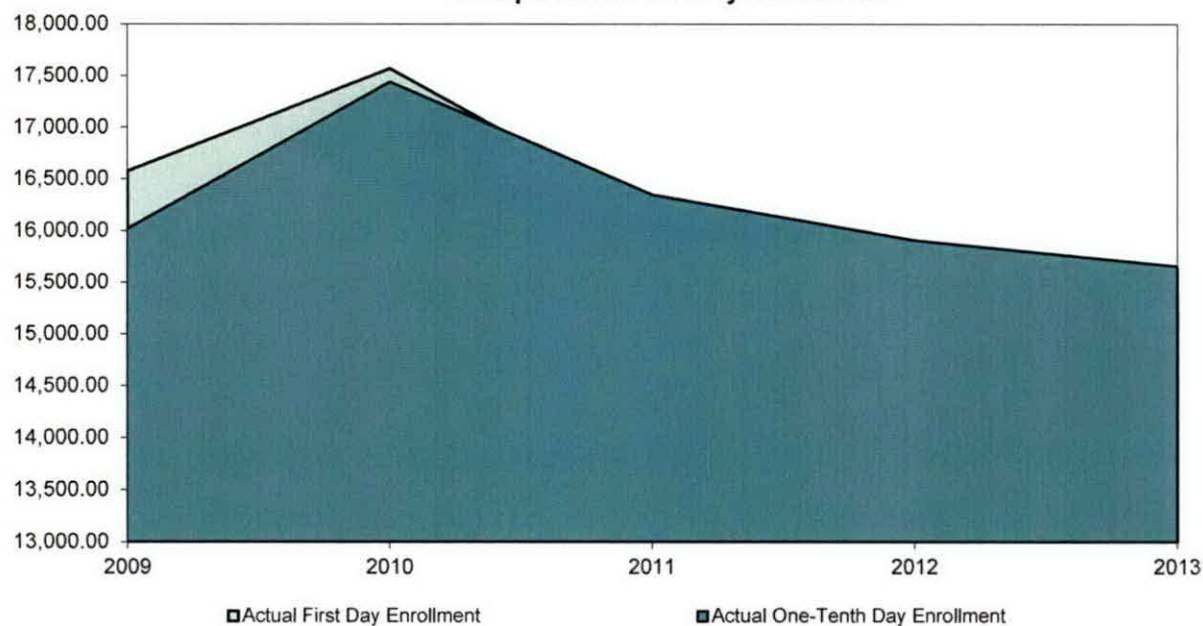

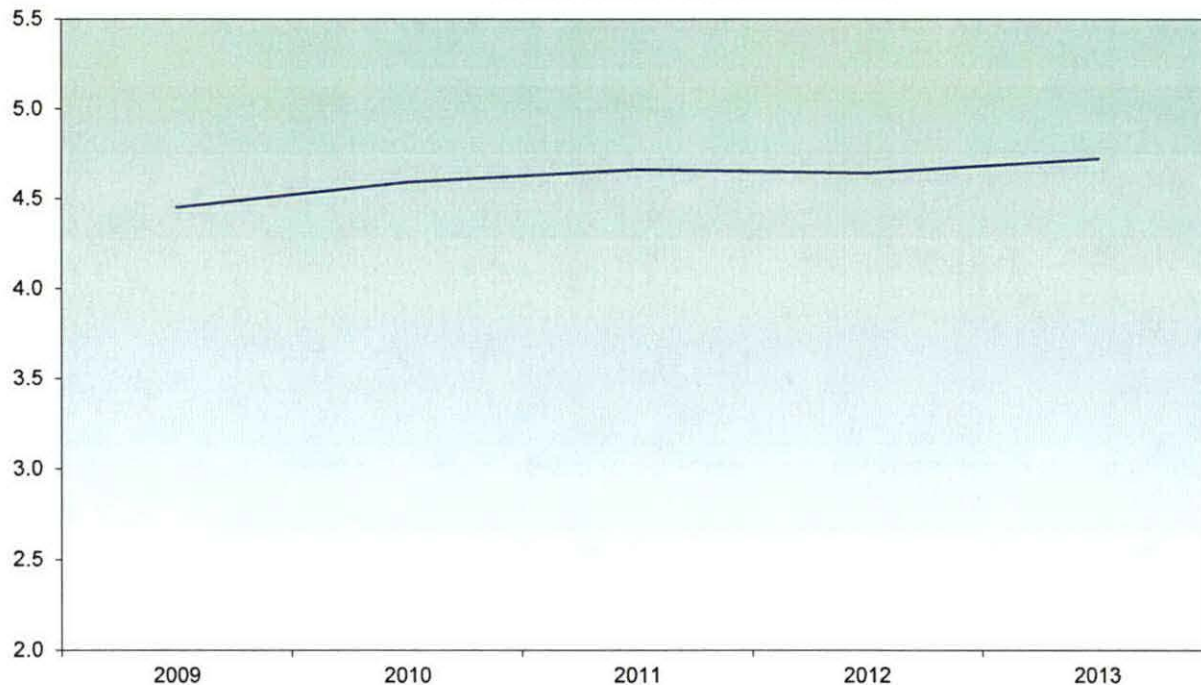

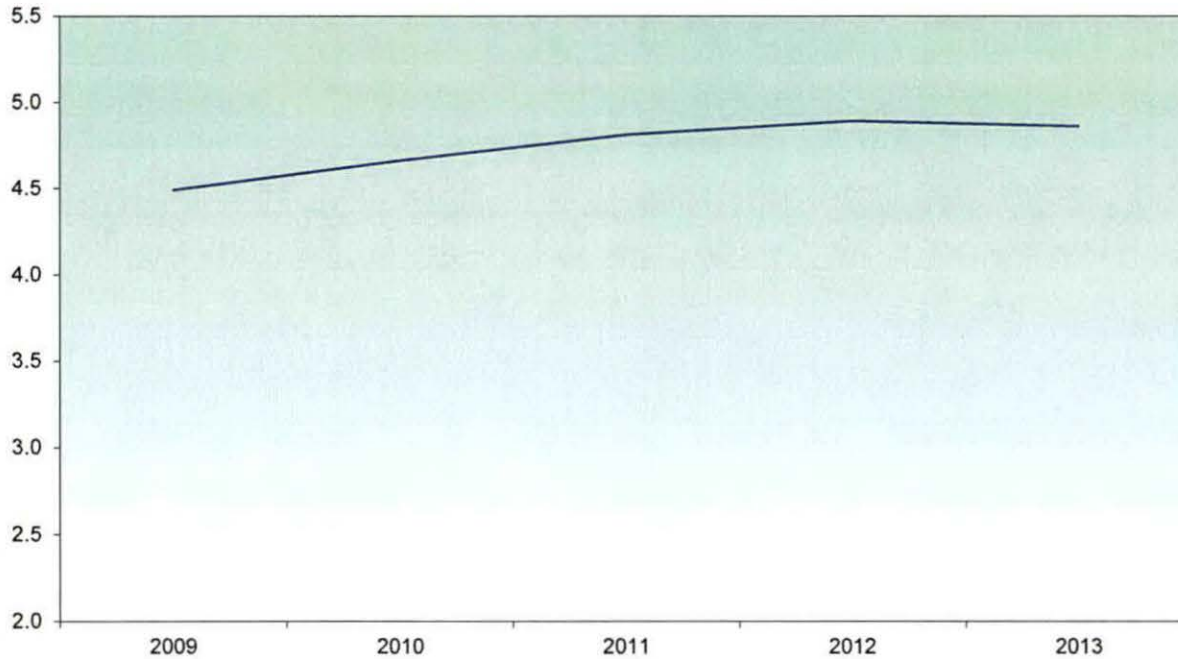

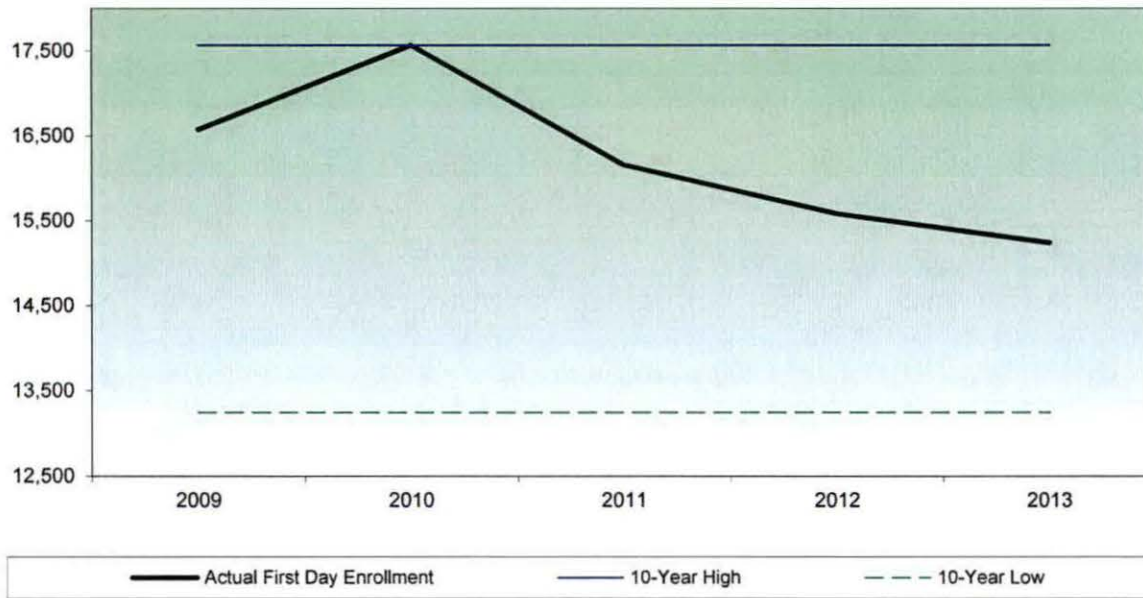

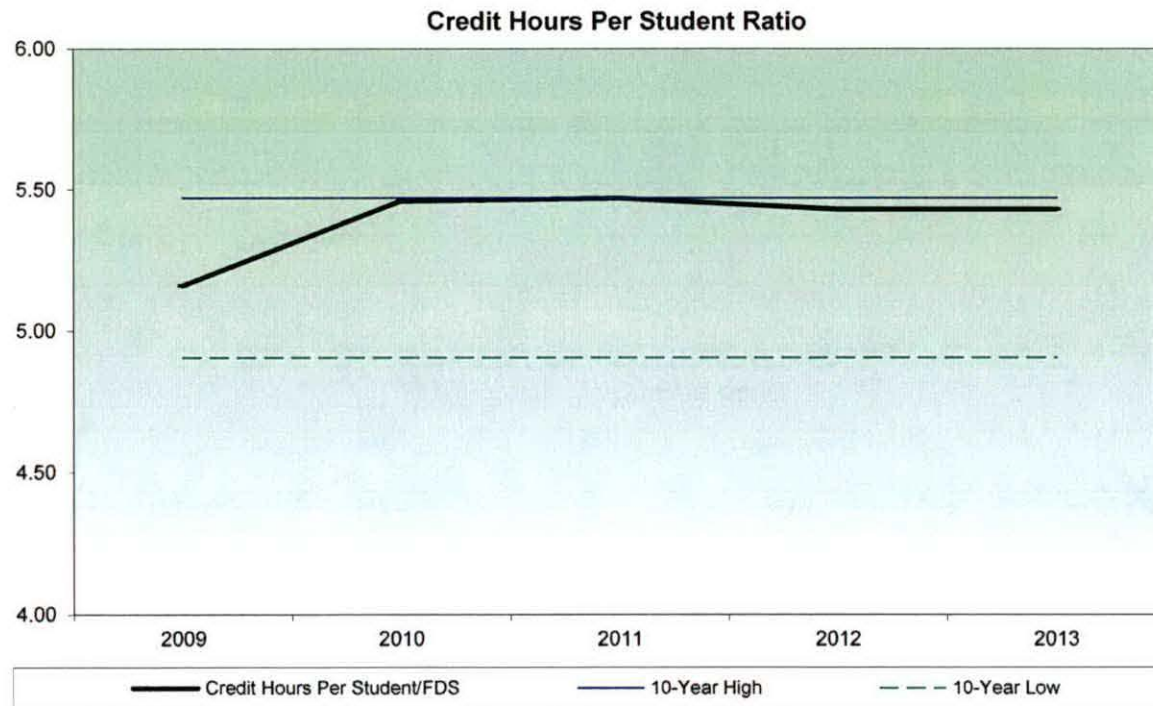

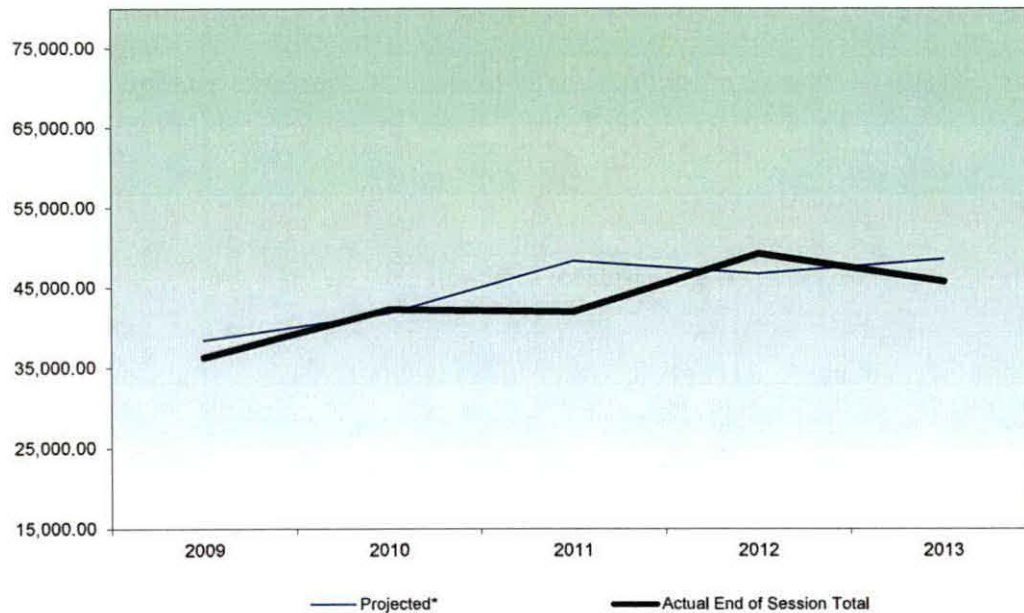

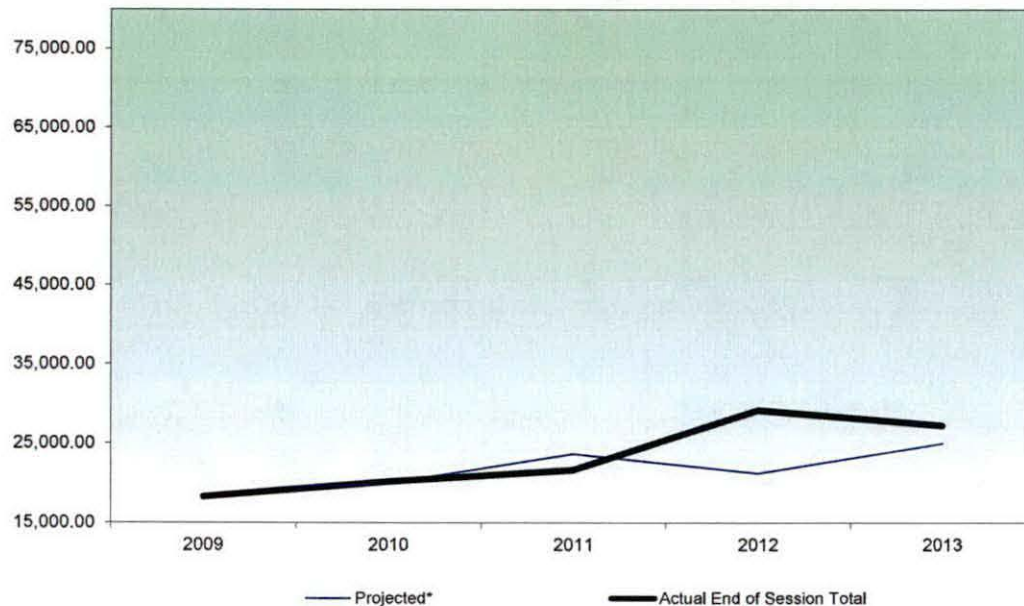

Credit Hours Per Student Ratio



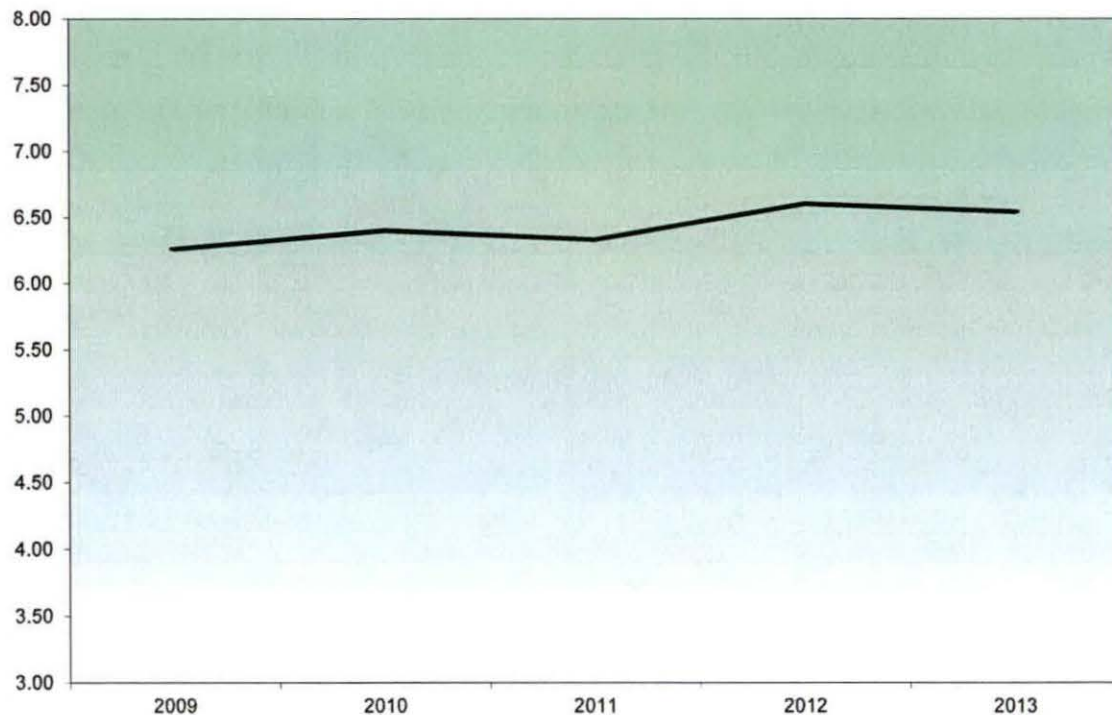

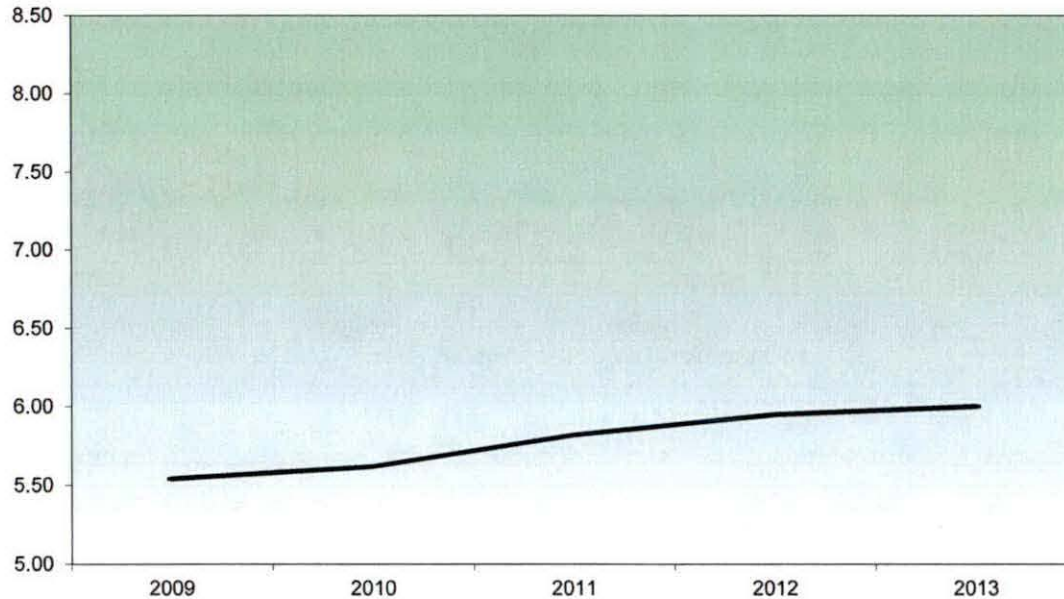
