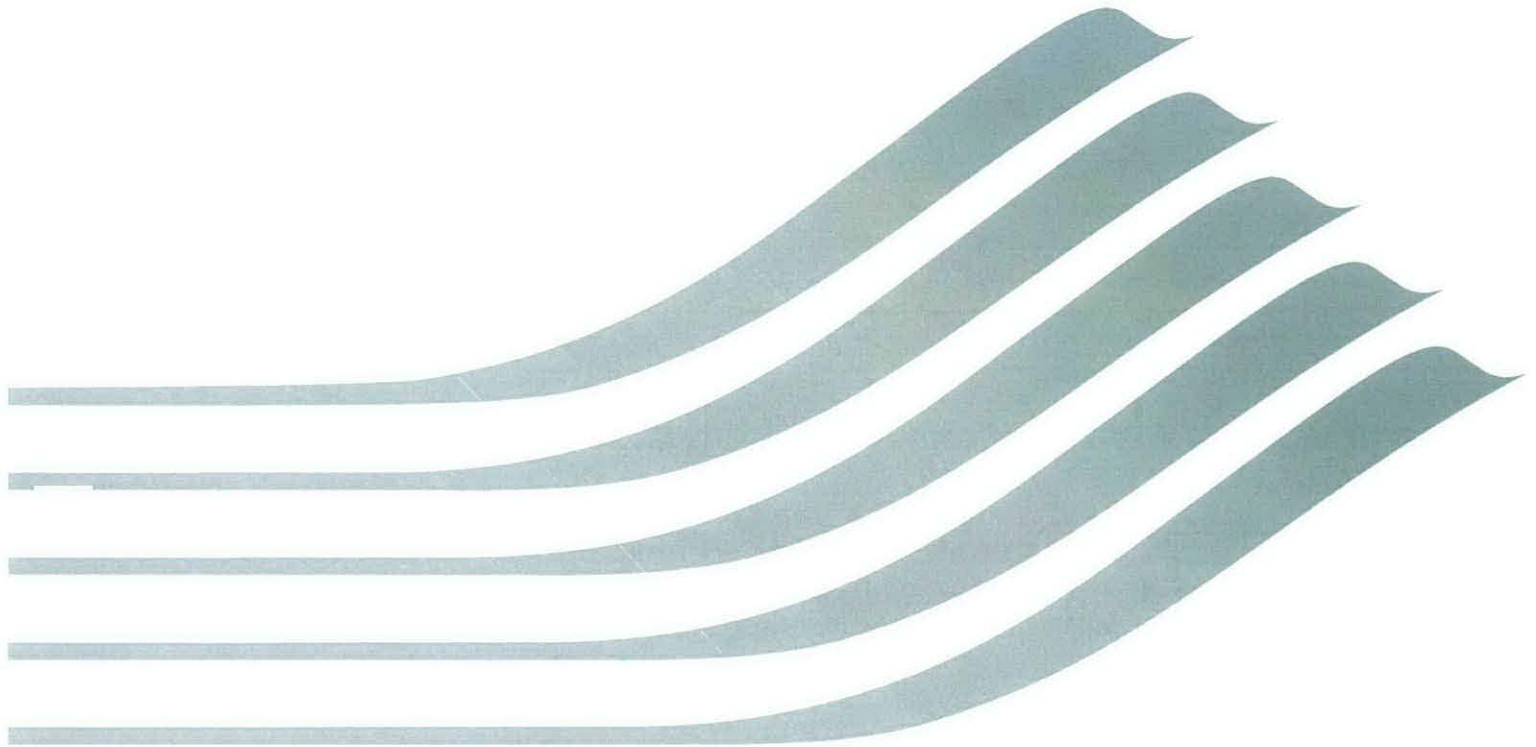

The following report contains data related to:

- student credit hours
- total student headcount

This report includes a comparison of *College-Wide One-Tenth Day* enrollment figures with *First Day of Session* figures for the same term.

All individual campus *Student Credit Hours* and *Headcounts* can be found in the *Credits per Student* tables.

In brief:

- College-Wide Student Credit Hours (23,064.00) **decreased** 9.9% when compared with the same time period last year. Over a five-year period (2010 to 2014), credit hours **decreased** 26.7%.
- College-wide Student Headcount (5,640) **decreased** 9.5% since last year, and **decreased** 27.1% since Summer II 2010.
- College-Wide Credit Hours per Student (4.09) **decreased** 0.5% since last year. Over the five-year period, this figure **increased** 0.5%.

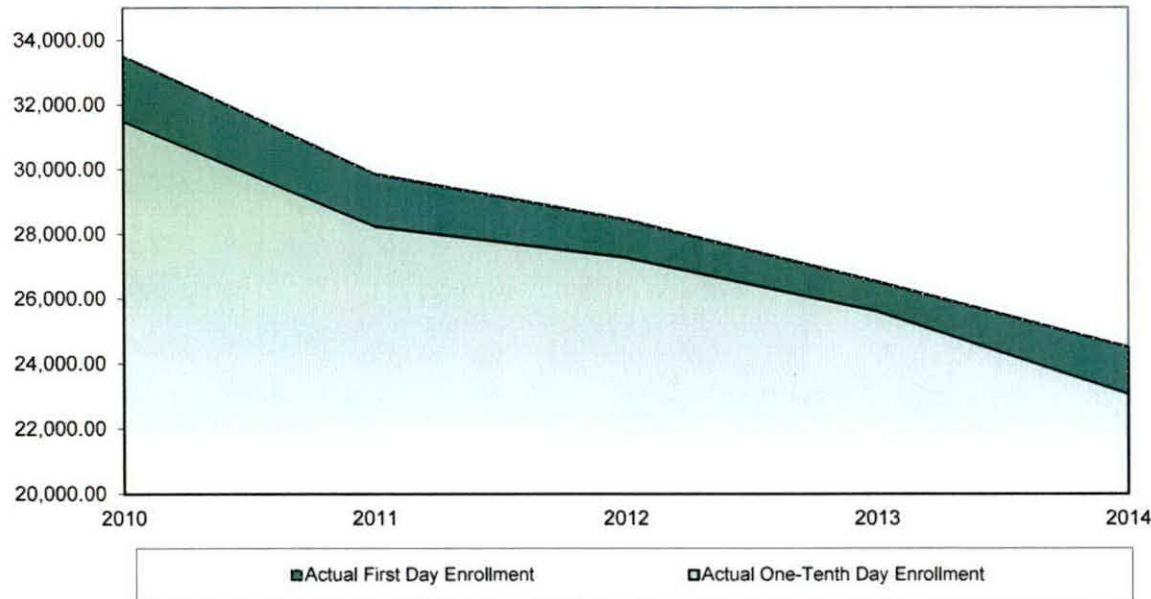

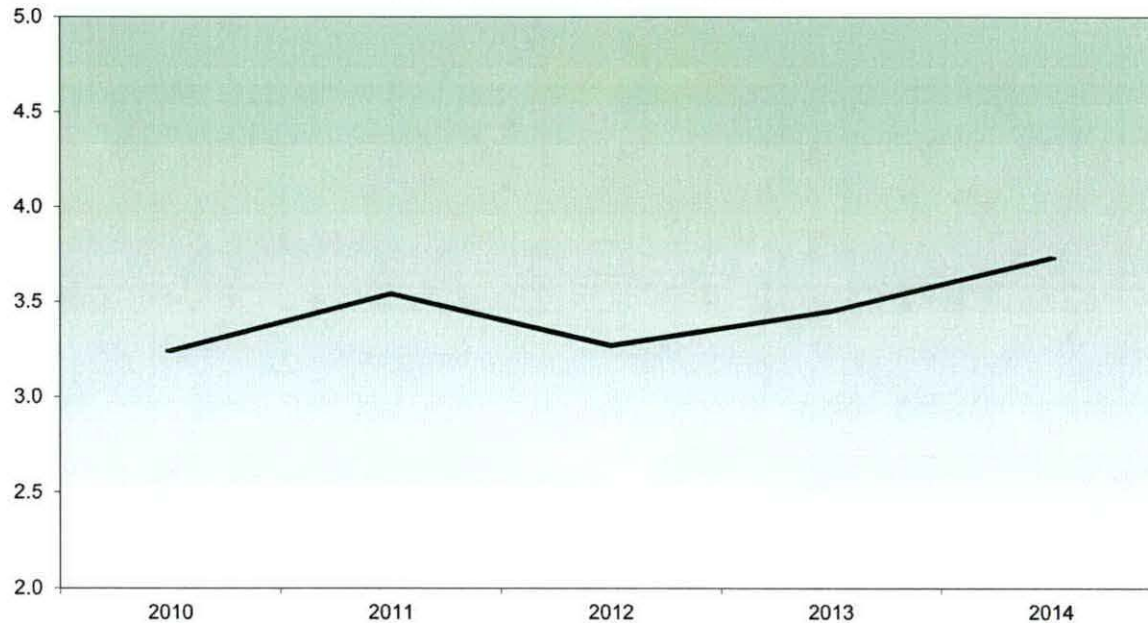

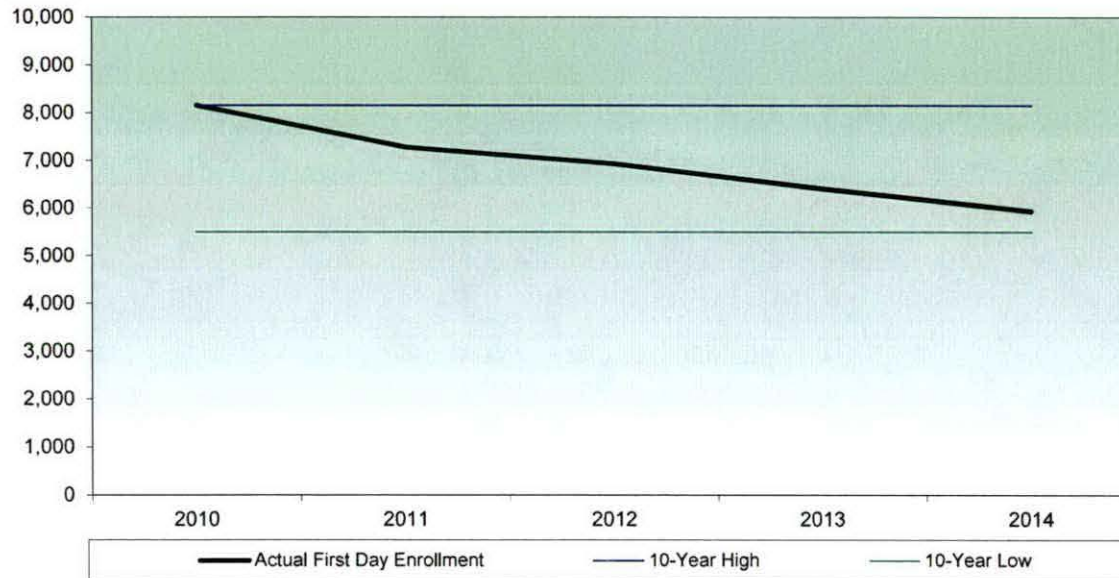

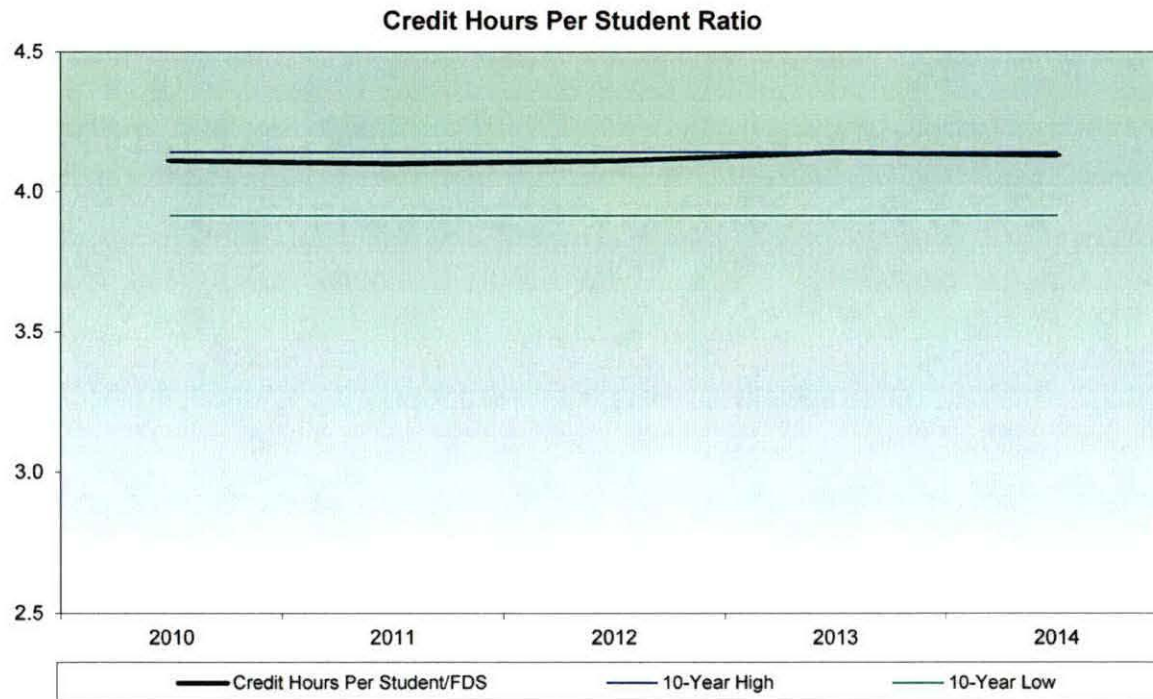

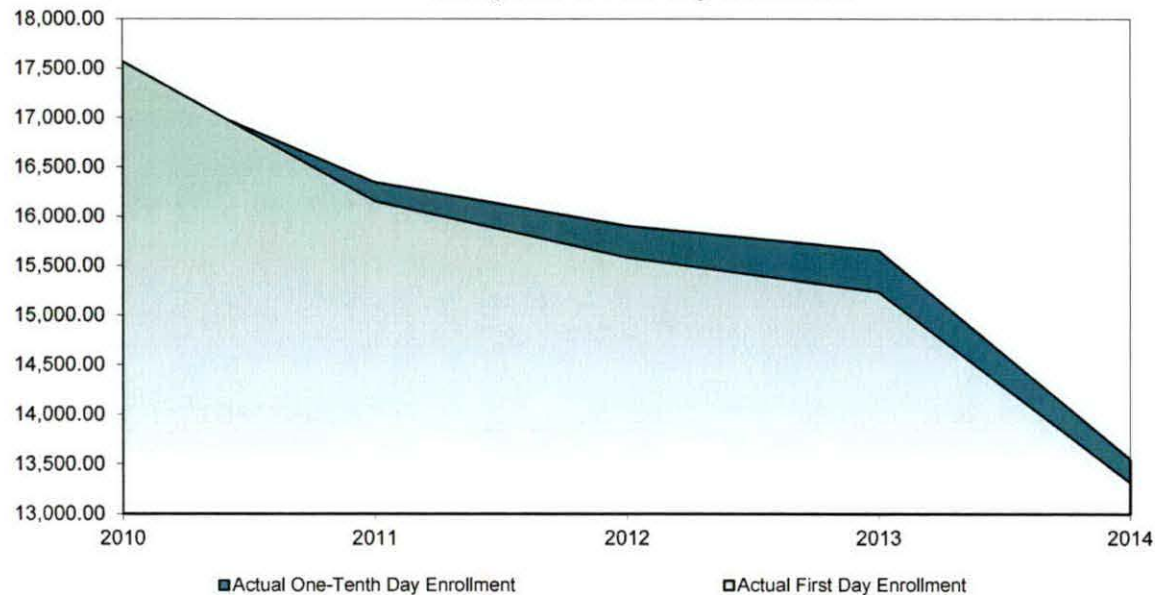

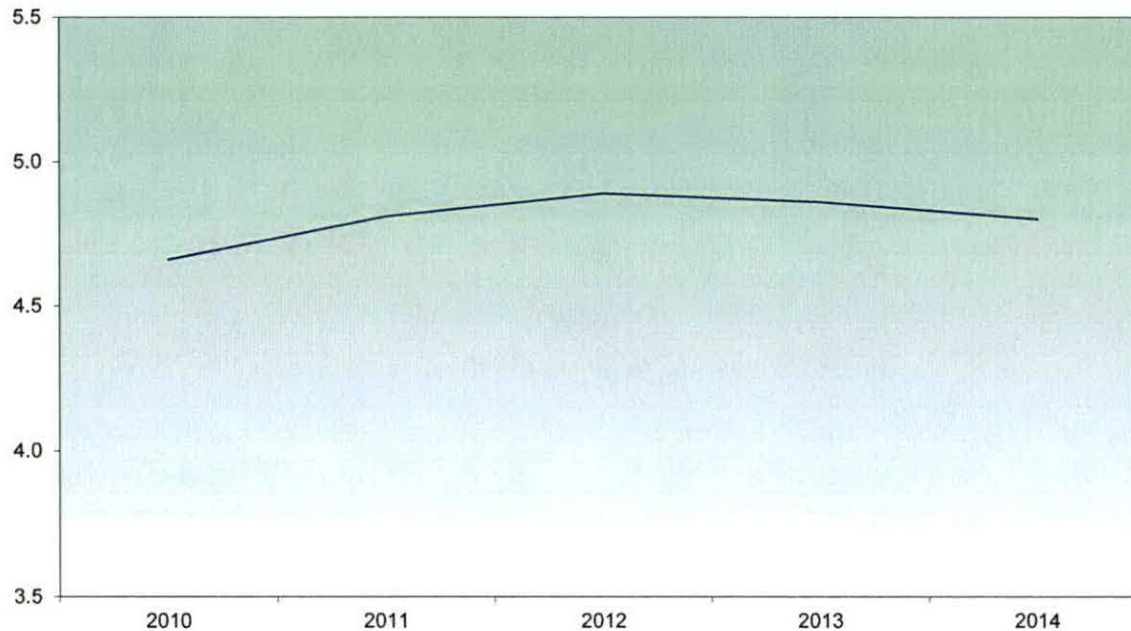

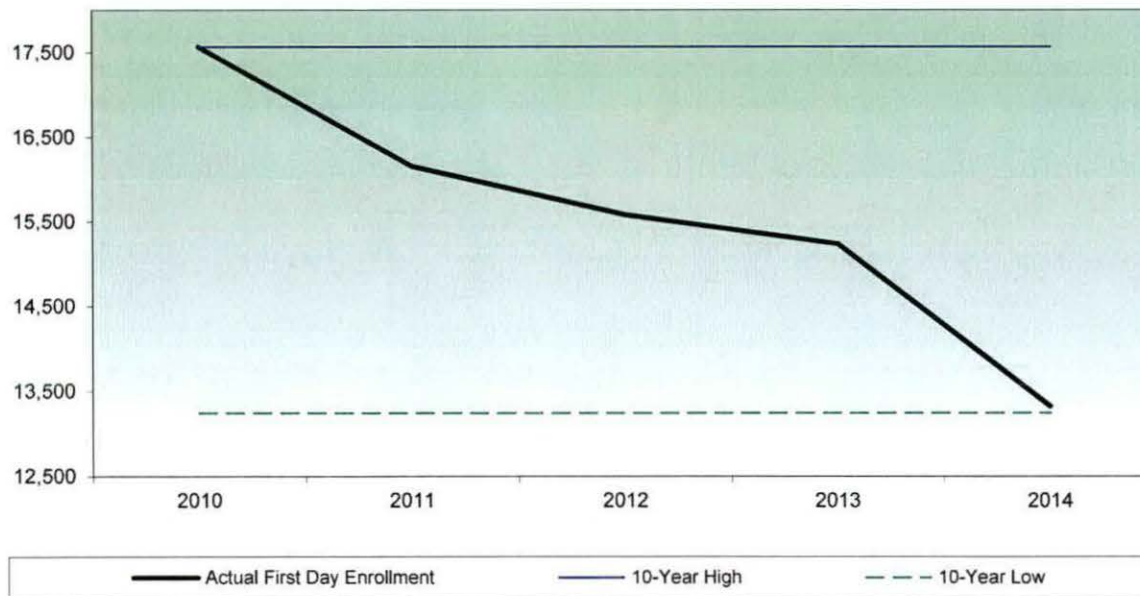

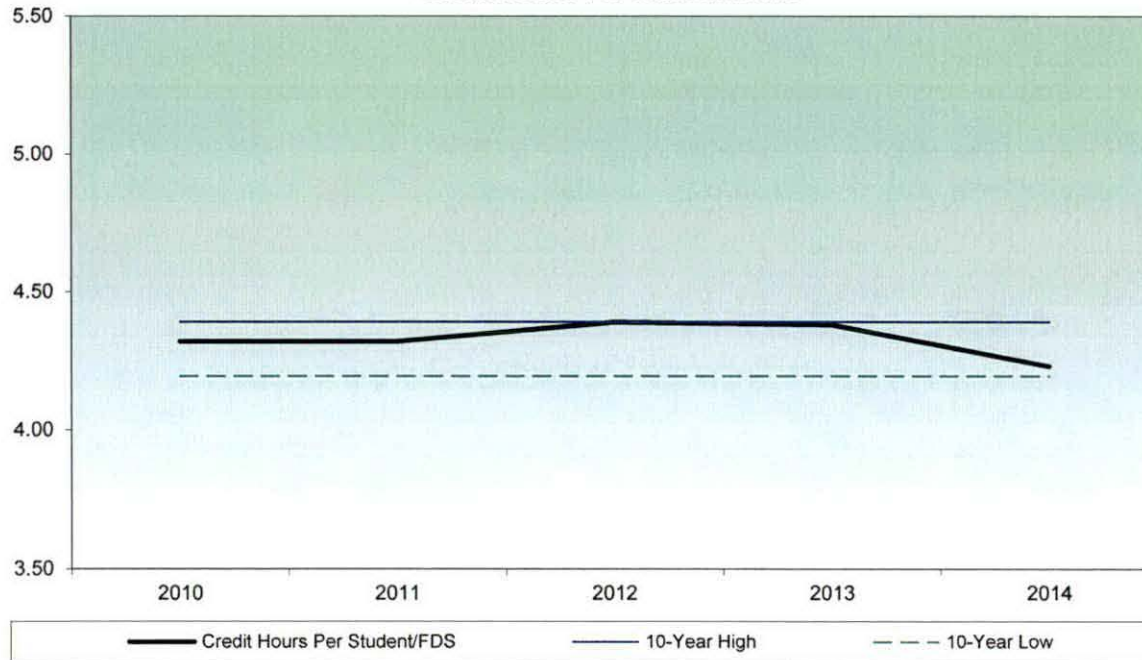

The following report contains data related to: 1) the number of student credit and non-credit hours; 2) total student headcount; and 3) the number of credit hours per student; as well as projections college-wide and by campus.

This report can be summarized by the following:

- College-Wide Student Credit and Non-Credit Hours combined (214,338.24) **decreased** by 5.5% when compared to the same time period one year ago. Over a five-year period (2010-2014), combined Credit and Non-Credit Hours **decreased** by 1.5%.
- College-wide Student Headcount (26,592) **decreased** by 6.3% compared with the same time period last year, and **decreased** by 7.4% over the five-year period.
- College-Wide End of Session Credit Hours per Student (8.06) **increased** by 0.9% over last year, and **increased** by 6.3% over the five-year period.

Credit hours and headcount fell relative to Winter 2013 (1-year) and Winter 2010 (5-year), but credit hours per student rose relative to the 1-year and 5-year figures.

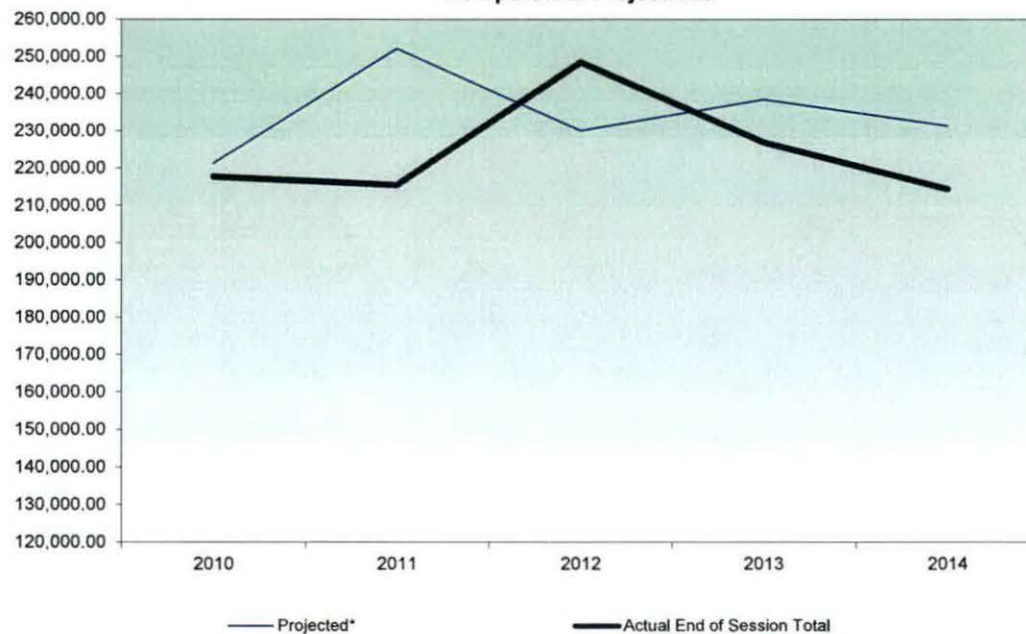

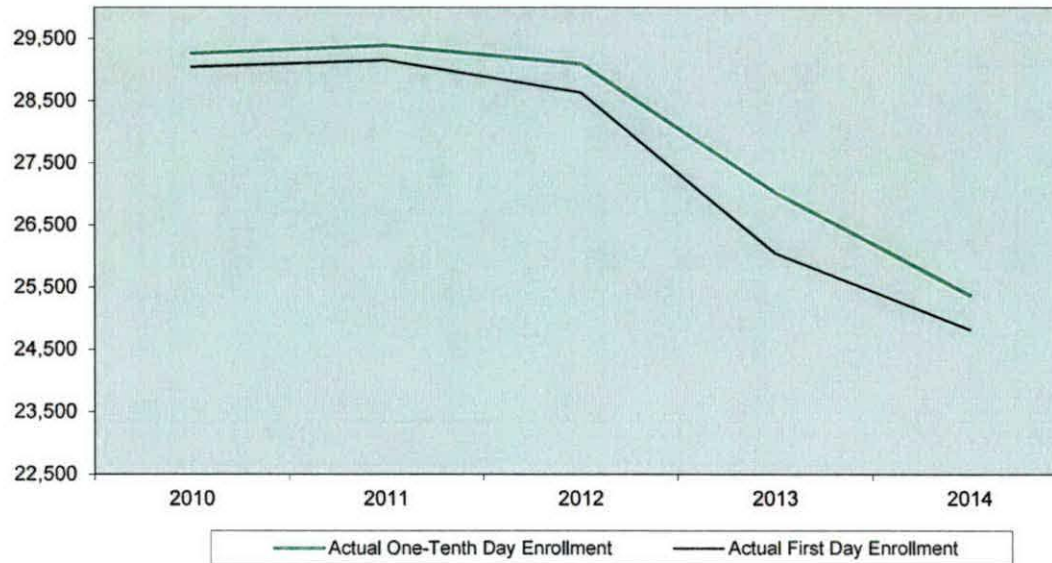

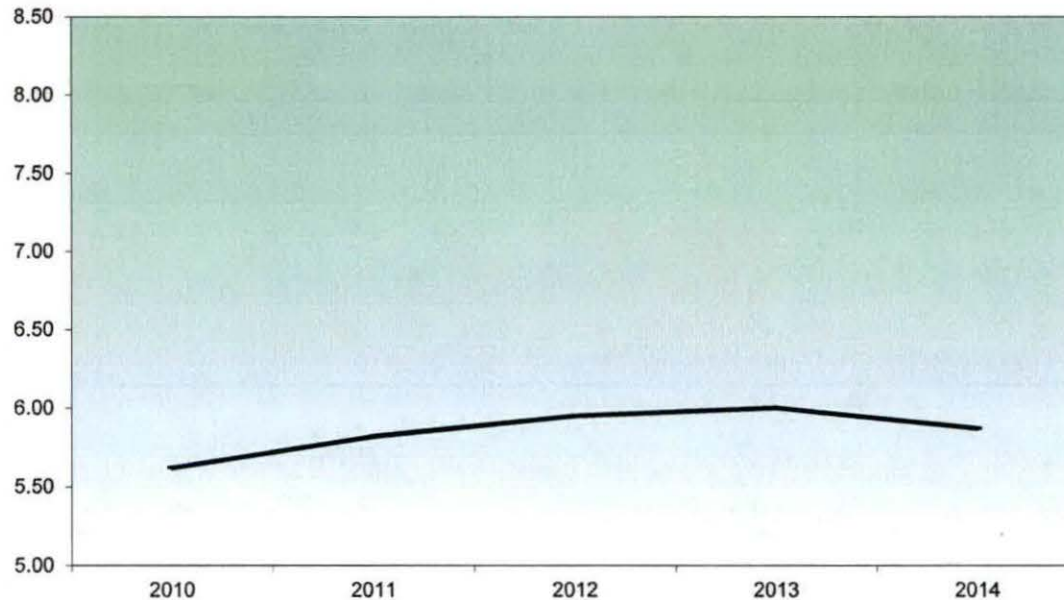

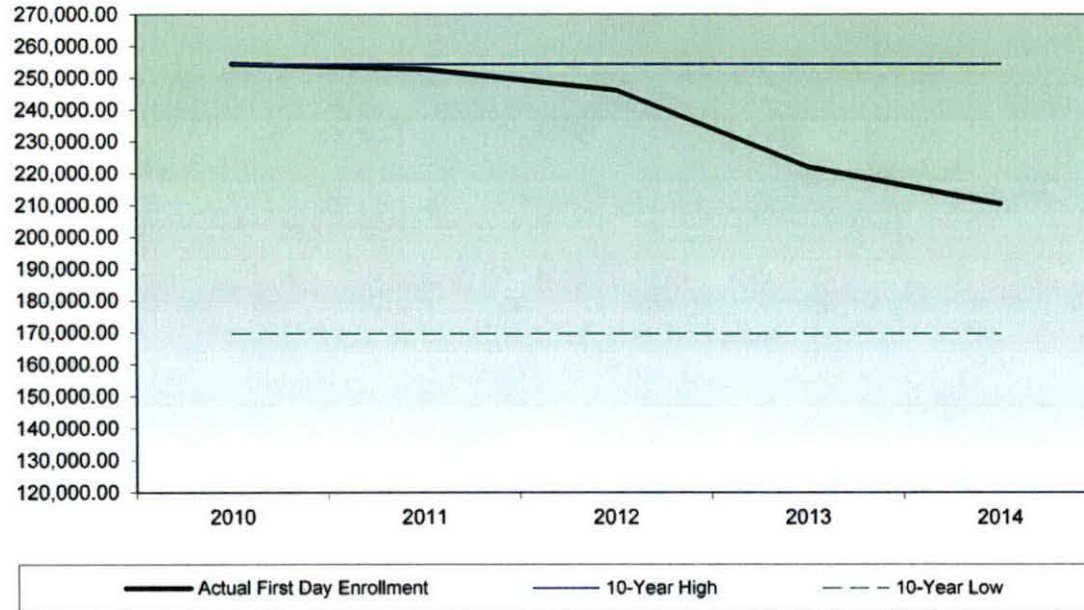

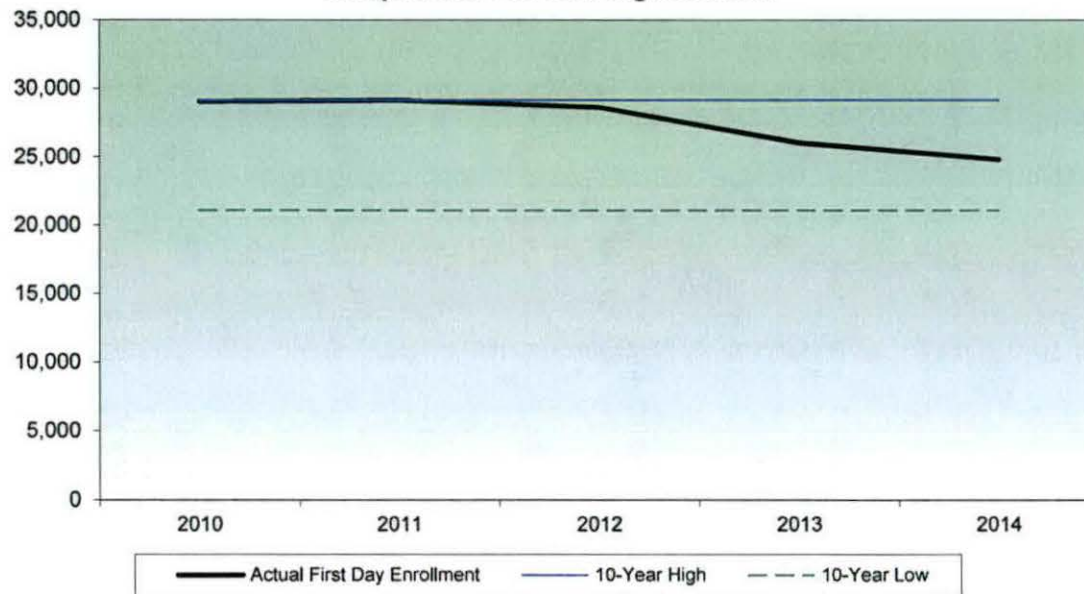

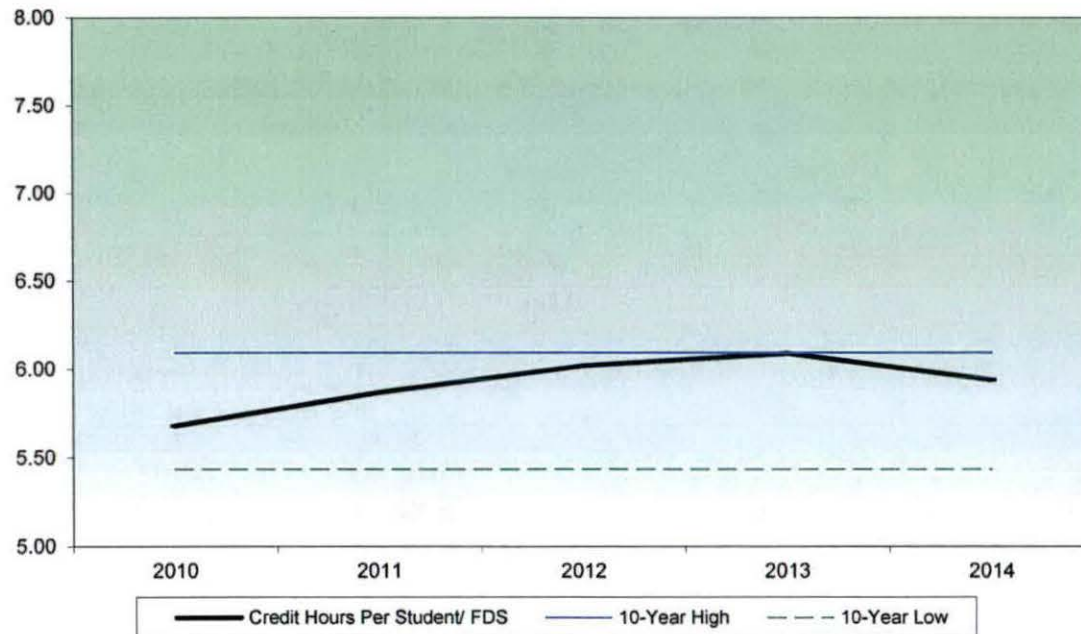
