

DALNET CIRCULATION STANDARDS COMMITTEE MEETING

Minutes - October 29, 1993

1. DALNET Access Committee

G. Bosler reported that he presented the Committee's draft of its charge to last DALNET meeting; it was approved. At this point, the Board has charged the Committee with responsibility for publishing the DALNET Access Directory and for PACLoan implementation. The Committee is not being directed to address other aspects of its charge, i.e. reciprocal borrowing and onsite delivery, at this time.

P. Spyers-Duran offered to have the Directory produced at Wayne State. G. Bosler is in contact with all of the DALNET libraries; he is still awaiting updates from some of the them.

L. Bugg has forwarded 10 policy questions relating to PACLoan implementation to the DALNET Access Committee for its consideration. The Access Committee will be responsible for addressing the policy components of PACLoan Implementation; our Circulation Standards Committee will be responsible for the actual implementation of this new capability.

2. QuikReports

The Systems Office has now successfully run all of the Circulation QuikReports. C. Wecker distributed copies for Committee review of those that were run since the last meeting:

CIR004 Missing Items Report

This report was not judged to be extremely useful -- except perhaps for a large library with thousands of items charged to "missing." The same information is already available online through use of the "has" command for the "missing" pseudo-patrons. With the "has" command, the information is available by "Service Unit" which is far more useful than the sort by Processing Unit with QuikReports.

2. QuikReports (continued)

CIR006,007,008 Items Charged-Out, Renewed, Discharged
by terminal, by time of day

The Committee felt these reports might be useful, on occasion, to justify increased staffing, longer hours, etc.

CIR018 Statistical summaries of above 3 reports

This report presents a single statistical summary of all three types of circulation transactions. This format is probably the most useful way to present this information for the purposes stated under CIR006,007,008.

CIR019 Graphic display of all three types of circulation transactions from CIR018

This report might have a more limited use since it does not indicate workload by terminal.

C. Wecker answered questions about reports distributed at the September meeting, as follows:

CIR005 Bill and Fine Summary Report

Clarification regarding the definition of an "active" record was sought from NOTIS. Any record still on the file (i.e. not purged), qualifies as "active". This includes both open and closed records. The Committee felt it might be useful to run this report annually to determine amounts of monies collected during the last year. It would be more useful if it could be sorted by Service Unit and date range.

2. QuikReports (continued)

CIR017 Summary Patron Usage Statistics

C. Wecker clarified the statistical summary portion of the report which includes: number of patrons in each category who currently have items charged; number of total items currently charged out to that patron category; mean number charged out to each person in that patron category; standard deviation (i.e. range) of number of materials charged out to each person.

As currently designed, this report would only be useful for patron categories which are unique across DALNET institutions. If it could be run by Processing Unit, it might be useful to produce on occasion. It might also be more useful if it could be done for a date range rather than as of a single date. The Committee wondered if only active patron subrecords are counted or if it also counts those blocked for "stolen" or "lost". If the latter is the case, it would give a false count of numbers of patrons per category.

3. Bill and Patron Record Purge

C. Wecker discussed the parameters for the Bill and Fine purge that will be done annually at the end of December. She reviewed a sheet indicating the results of a "test" purge done using these parameters. Almost 1/2 of the 867,870 Bill and Fine records present at the time of the "test" would be purged.

To ensure that the purged records can be remounted and accessed in the future, D. Fox will load the "test" purged records and a copy of the patron file at the time of the purge in a test region for review by C. Wecker and J. Pearson. When Release 5.2 is implemented, it will be necessary to convert the Bill/Fine file records. The Systems Office will use the 5.2 conversion programs to also convert purged files and copies made of the patron and Bill/Fine file to ensure that purged records can be accessed, as necessary, once Release 5.2 is implemented.

After the bill file purge, the Systems Office will work on the desired reports in preparation for the Patron Record purge:

- (1) identification of records with expired, but not delete, dates and
- (2) identification of patron ids not used for the past 2-3 years.

4. Statistical Reports by Call Number Range/Location/Patron Category (Vandy Report)

C. Wecker announced the schedule for running this report: six month reports will be run for each institution at middle and at the end of its fiscal year. Reports will, therefore, be run the beginning of January, April, July, and October. In addition, a two year report for the period directly preceding each library's first semi-annual report will be run for each DALNET site.

5. PACLoan/Intercampus Loan

C. Wecker announced that an updated version of PACLoan was sent to the development site in mid-October. NOTIS hopes this will be the last iteration and that it will be available to customers by the end of 1993.

6. Release 5.2 Circulation Rewrite Preview

C. Wecker distributed copies of 5.2 prototype screens and a descriptive handout from the NOTIS Users Group Meeting (NUGM) in mid-October. She also distributed her "draft" report on the "Rewrite". She and T. Potvin (who also attended NUGM) reviewed these documents and what they learned regarding the new release. There are no screen prototypes yet on course reserve, bill and fine, or recall/hold functions; the redesign of these has not yet been completed.

Tom Schneider, a member of the Rewrite Team, is accepting questions from users regarding 5.2; he will be reporting on these issues at the next two ALA meetings. Our Committee will develop a list of questions/concerns to forward to him by the end of November. The group reviewed the documents it developed as a response to the Rewrite Committee on the various parts of the Circulation Module to see if desired features seemed to be there and determine the relative importance of these features to the group. Committee members were asked to review those documents not covered during this meeting. T. Potvin, J. Pearson, and C. Wecker will develop a list of questions/concerns to send to Committee members for comments/modifications before being forwarded to T. Schneider.
