How 4 yr. Schools Use MTA

Wayne State:

Once you have received the MTA endorsement on your Michigan community college transcript you will have your Wayne State general education requirements satisfied. This could fulfill many degree requirements at Wayne State, and move you that much further along towards earning your bachelors degree! This will save you both time and money.

Eastern Michigan University

The Michigan Transfer Agreement (MTA) satisfies all of EMU's General Education Core requirements.

Oakland University:

Oakland University participates in the Michigan Transfer Agreement (MTA) and Michigan Association of Collegiate Registrars and Admissions Officers (MACRAO) Articulation Agreement. Both agreements allow students to satisfy the university's general education requirements at a Michigan community college, with the exception of a writing intensive course in the major and a capstone course.

Central Michigan University

If you have met the MTA and it is stamped on your official transcript, it will be applied to meet all general education requirements at CMU. In addition, it will satisfy one or more of the following competency requirements: In addition, each course will be individually evaluated and could also be used to meet major/minor or degree requirements.

Michigan State University

The MTA will satisfy all of Michigan State University's Integrative Studies requirements. OCC students will need to select His 2510 or His 2520 as one of the options for the MTA Social Science Requirement

Western Michigan University

Transfer students from colleges whose transcripts have been appropriately identified and certified as having fulfilled the requirements of the MTA by their respective Michigan community college will have satisfied WMU's lower-level General Education requirements. Such students need only satisfy Western's requirement of six hours of 3000-4000 level General Education course work from the distribution areas, and complete the baccalaureate-level writing course (Proficiency 2).

Northern Michigan:

Any student with <u>Michigan Transfer Agreement Satisfied</u> shown on the official transcript from the community college to have met NMU's Liberal Studies/General Education Program.

Grand Valley State University

Michigan Transfer Agreement/MACRAO satisfies Grand Valley's General Education Foundations, Writing 150, and one Supplemental Writing Skills course. Students transferring with a Michigan Transfer Agreement/MACRAO are still required to complete one SWS course in and one two-course Issues at GVSU.

Ferris State University

Students transferring to Ferris with the Michigan Transfer Agreement (MTA) and entering a degree program will have met a 30 hour block of lower-level general education courses.

Michigan Tech:

Students who transfer to Michigan Tech with the MTA endorsement from their community college will have the MTA credits applied to the general education requirements for a bachelor's degree in the following manner: Students who transfer to Michigan Tech having completed the MTA are expected to complete the remaining general education (6 HASS cr. @ 3000/4000 level & 3 cr. from any MTU Gen Ed list) and degree requirements as required for the completion of their program.

Lake Superior State University

Students who complete the MTA and transfer to Lake Superior State University will be considered to have met the General Education Core requirements. Students will still be expected to complete all other degree requirements as required for the completion of their program.

Saginaw Valley State:

If your transfer transcript reflects either MACRAO or MTA completion, then all 30 of your MACRAO/MTA credits will be applied so that you will have met 30 (the majority) of SVSU's general education requirements. The remaining 2 CI courses are to be taken at SVSU.

University of Michigan – Ann Arbor

U-M Policy on Implementing the Michigan Transfer Agreement

- •The University of Michigan supports the principles that underlie the Michigan Transfer Agreement (MTA) as published in February 2014. We value the transparency and student focus that underlie the Agreement.
- The University of Michigan does not have a general education requirement. Courses in the MTA block will be individually evaluated for their role in meeting degree requirements as outlined in the MTA implementation handbook.
- •The University of Michigan will evaluate individual courses in the MTA block for transfer, and if transferable will place these courses on a student's transcript as transfer credit.

University of Michigan – Dearborn

In the spring of 2014, the University of Michigan-Dearborn signed the Michigan Transfer Agreement (MTA) to participate as a receiving institution. The MTA permits transfer students to complete the 30-credit hour Michigan Transfer Agreement at a Michigan community college and transfer it as a block to satisfy most of the general education requirements at Michigan universities.

University of Michigan - Flint

The University of Michigan is committed to helping students transition smoothly from their community college to UM-Flint. This commitment is demonstrated by our participation in the Michigan Transfer Agreement (MTA).

The simplicity and flexibility of this agreement allows a transfer student to work towards the completion of the general education requirements of the community college and a four-year institution at the same time. If done carefully, students may also satisfy additional major, minor, and general education requirements specified by the receiving college. This will greatly reduce the likelihood of taking courses at one institution that do not apply toward the completion of a bachelor's degree.
