The potential growth and expanding development of the college demands the services of many individuals of varying personalities and abilities.

Wheeler Utley, upon receiving the acceptance of the Board's invitation to membership from the persons asked to serve, expressed deep appreciation for their willingness to help the cause of Christian education at Michigan Christian College. The most recent additions to the Board represent

Michigan Christian College had its beginning in an informal meeting of Christian men of the Detroit area in the spring of 1954. In September of that year a nine man Board of Directors was chosen. Many of these original men still serve, including the entire Executive Committee. The Fall of 1968 marks the beginning of the Board's fifteenth year of service

They determined to establish a private, co-educational junior college offering standard work in the liberal arts and sciences undergirded by a daily Bible course for every student. Thus Michigan Christian College was established, a non-profit corporation under the laws of the state of Michigan.






