Scheduling difficulties at Cobo Hall in Detroit have resulted in a major date change for Partnership Dinner X. A January 21 letter from a Cobo official stated, "It is with sincere regret that I must inform you of a scheduling problem on our part that makes your dinner too close to other functions ... so that in our judgment we would not be able to properly serve you. I wish to state emphatically that the responsibility for this problem falls squarely on our shoulders." Consequently, May 9, 1981, has been selected as the best of two open dates at Cobo Hall for Partnership Dinner X.

As a courtesy in view of the scheduling problem, Cobo Hall plans to serve their finest menu entree. Tickets to the dinner will remain at \$60 for adults and \$30 for students, although a slight increase is anticipated for following years. Despite dramatic increases in food costs, the ticket price for the dinner has remained the same since Partnership Dinner II in 1973.

Currently, local chairmen are being selected in approximately 115 congregations which represents an increase of twenty participating congregations. Thirteen goal setting sessions are scheduled between February 21 and March 22 to assist local chairmen and their assistants in setting local goals. The sessions, scheduled at geographically convenient congregations throughout Michigan and northern Ohio, are also designed for participants to share ideas and to inspire one another for greater growth of the dinner in spite of the current national economy.

Last year, Partnership Dinner IX drew 2,520 friends of Michigan Christian College to Cobo Hall with a total of 3,148 tickets sold. Proceeds from the dinner again met the annual \$139,000 payment on the Alma Gatewood Memorial Residence Hall.

Not only has Partnership Dinner developed as the largest annual gathering of Christians in the Midwest, but has provided a tremendous stabilizing influence on the college for nine years. No other region of the country has ever accomplished a more dramatic effort on behalf of Christian education. Mark your calendar and plan to be a part of this exciting event!

Complete details and guidelines for the clubs will be announced in the next bulletin.

Also, in connection with the launching of our new Estate Planning program, we are establishing a club designed to honor those individuals and families who include Michigan Christian College, on a noncontingent basis, in their Estate Plans.

Again, let me say that Michigan Christian is so thankful for every gift, regardless of size. Without every contribution the institution could not continue to offer our young people the high quality programs that are available.

#### Estate planning assistance program now available

Educational institutions are financed by several types of income; namely gift income, earned income from student tuition and fees, earned income from auxiliaries such as the Bookstore, and earned income from Permanent Endowment. National statistics reveal that approximately 80% of endowment gifts to educational institutions come from Estate Planning programs. At the present time, Michigan Christian College has a very small Permanent Endowment Fund.

Permanent Endowment can best be described as a "savings fund" that can be used only for the purpose of producing income. The "corpus," or the fund itself, cannot be expended but only the interest it earns can be used. For a small private educational institution to survive the ravages of a poor economy, it desperately needs permanent endowment. How wonderful it would be for Michigan Christian College to develop a significant Permanent Endowment fund capable of producing income to assist the operating budget each year. This could aid immeasurably in controlling tuition increases and thus be of great benefit to students.

Additionally, some Estate Plans will produce gifts for construction of new facilities desperately needed in the institutional growth

Michigan Christian believes that every donor should derive benefit and blessing from his or her gift. If giving is a grace (and we all believe it is) then certainly giving is more blessed than receiving. That being true, the greatest benefit derived from giving is the personal satisfaction one receives. In relation to Estate Planning agreements, Michigan Christian believes that — "If it isn't a good deal for the donor, it isn't a good deal for the institution." Every Estate Planning proposal is approached with that in mind. In addition there can be valuable savings on Federal Estate Taxes, State Inheritance Taxes, and, in relation to Life Income Agreements, Federal Income Tax savings.

At the January 17, 1981 meeting of the Board of Trustees, President Milton B. Fletcher presented for their consideration and approval, a set of Estate Planning Policies. These will become the guidelines for the institution's Estate Planning program.

The Estate Planning program is offered as a service free of charge. We have adequately trained and experienced people in the field of marketing Estate Planning programs. Professional legal advice is also available on the staff. Opportunities to make public Estate Planning presentations are welcomed. 
#### Registrar, Math Instructor added to MCC faculty
