## 3.2 College Security Review Update

The draft Security Review Task Force recommendations were reviewed by Chancellor's Council. Initial comments were made after a preliminary review.

Chancellor's Council has requested final recommendations to the Securacomm report and the Security Review Task Force report for final review at the Chancellor's Council meeting to be held on February 26, 2002. Final recommendations are to be presented to the Board of Trustees at their regularly scheduled meeting in March.

The following recommendations were made by the CASC in reviewing the Securacomm security recommendations and the Security Review Task Force recommendations:

### Securacomm Recommendation #1

CASC agrees with recommendation but needs detailed information on transition from a police operation to a public safety operation.

Chancellor's Council requests information on the use of a combination of both public safety staff and community service staff.

### Securacomm Recommendation #2

CASC agrees with recommendation but needs to define specific "highly visible locations." Agrees with the expanded definition to "focus on visibility, prevention, communication and pro-active interaction..."

#### Securacomm Recommendation #3

CASC agrees with recommendation to update the Public Safety Department operation manual to reflect current conditions.

#### Securacomm Recommendation #4

CASC agrees with this recommendation. It is anticipated that the position of Director of Public Safety will be filled in February or March.

## Securacomm Recommendation #5

CASC agrees with this recommendation.

#### Securacomm Recommendation #6

CASC requested that this recommendation not be considered since it is out of the scope of this report. It was the recommendation of the CASC that public safety be available during all staff working hours.

### Securacomm Recommendation #7

CASC requested that this recommendation be evaluated along with recommendation number 1. Further definition is required as to "non-critical" and roles of public safety officers.

### Securacomm Recommendation #8

CASC requested that this recommendation be evaluated along with recommendation number 1.

CASC recommends that any person who works alone should be equipped with a portable "person down" transmitting device.

Securacomm Recommendation #23

CASC agrees with this recommendation. Requested that further information gathering be conducted to determine the best method of dispatch service.

Securacomm Recommendation #24

CASC recommends that this recommendation be reworded to recommend that the College move toward a more central computer based access system.
