#### **Minutes**

## 1. Approval of Minutes

Minutes from the August 5, 1999 DALNET Database Standards Committee Meeting were reviewed and approved and will be sent to the DALNET Project Managers and DALNET Board.

# 2. Review of Agenda

### 3. Review of Dalnet Database Standards Revisions for Horizon

#### A. Provisional Records

The Committee reviewed and edited "Guidelines for Creating Provisional Records." Because the guidelines will only be for items that are displayed to the public it was determined to change the name to, "Guidelines for Creating Provisional Records for Public Display." D. Roe will edit and send to F. Krempasky who will present them at the September 8, 1999 DALNET Project Managers' Meeting.

# C. Bibliographic and Authority Database Standards

The Committee began reviewing and revising this document. It was suggested that the name be changed to, "DALNET Standards for Bibliographic and Authority Databases." A. Lim advised that this standard may also have to be revised when image databases become available in DALNET catalogs. M. Howarth will edit the document and send to F. Krempasky for the next meeting.

# 4. Discussion of h (medium) and Title Indexing in Horizon

A. Lim discussed the background and history of decision to index and therefore display the |h subfield in Horizon. A decision was made before migration that the |h should display in title indexes to distinguish between records with the same title but in different formats. UDM did not index the |h field initially, but their indexes are being reindexed so that the |h should display in title searches.

### 5. MARC Standards in Horizon: USMARC vs. OCLC MARC

A discussion took place concerning the differences between USMARC and OCLC MARC. For example, the 090 field is often used as a locally assigned call number field in OCLC MARC, but in USMARC it is a defunct field and the 050 (blank)4 is used instead. This has become an issue because Horizon follows USMARC guidelines. The Committee determined that there needs to be an awareness of the differences by DALNET libraries, and libraries should still follow the Committee's Standards and Guidelines as a rule, which will be in USMARC format.

#### 6. Informational Items

## OCLC-MARC Processing Field 994

F. Krempasky introduced the new 994 tag in OCLC which is an expanded 040 field. Item mapping may have to be changed to include this field. A. Lim will look into further. R. Dotson discussed the item mapping of the 049 field and how the item record is built from it. B. Ho suggested that we monitor the 994 field and see if any unpredictable changes occur in the item record in Horizon from this implementation.
