EXECUTIVE SUMMARY**

The following report contains data related to: 1) the number of student credit hours; 2) total student headcount; and 3) the number of credit hours per student. Please note that Institutional Research has added a section indicating high and low enrollment figures for First Day of Session data over the past ten years.

All individual campus Student Credit Hours and Headcounts can be found in the Credits per Student tables.

In summary:

- The number of College-Wide Student Credit Hours has shown an increase of 3.1% when compared to the same time period last year. Over the five-year period (2000 to 2004) total Student Credit Hours increased by 12.2%.
- Student Headcount at the college-wide level has increased by 2.7% since 2003, while an increase of 4.8% is noted over the five-year period.
- College-wide, the number of Credit Hours per Student is 8.29. This figure represents a slight (0.4%) increase compared to last year, and denotes a 7.1% increase over the five-year time period.

Overall, compared to the same figures one year ago, increases were noted in all areas. Likewise, over a five-year period, College-Wide Student Credit Hours, Student Headcount and Credit Hours per Student each increased.

NOTE: Total Student Credit Hours (200,467.00) and Credit Hours Per Student (8.29) each represent the highest respective figures over the last ten years.

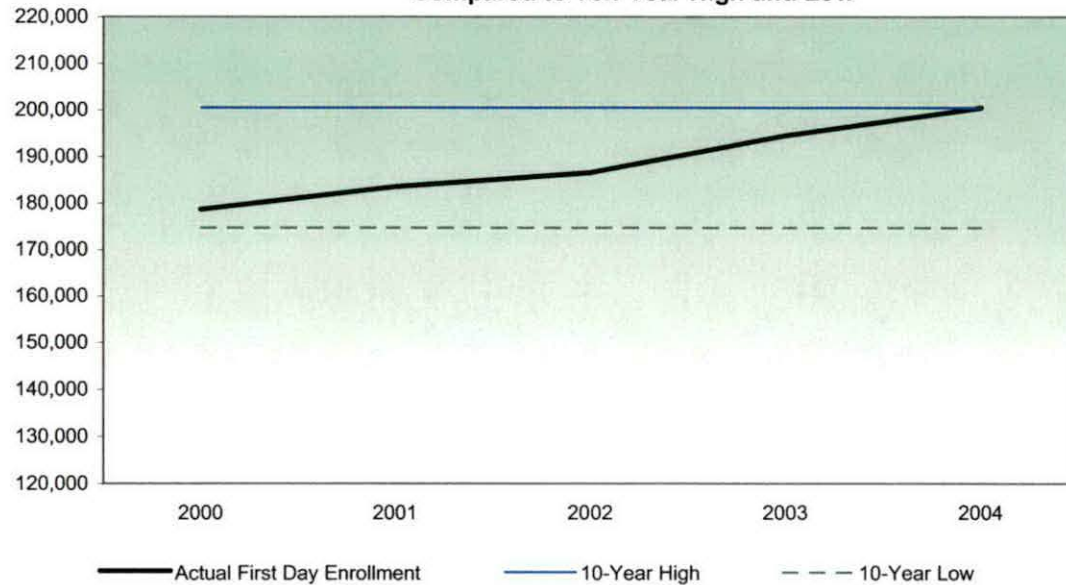

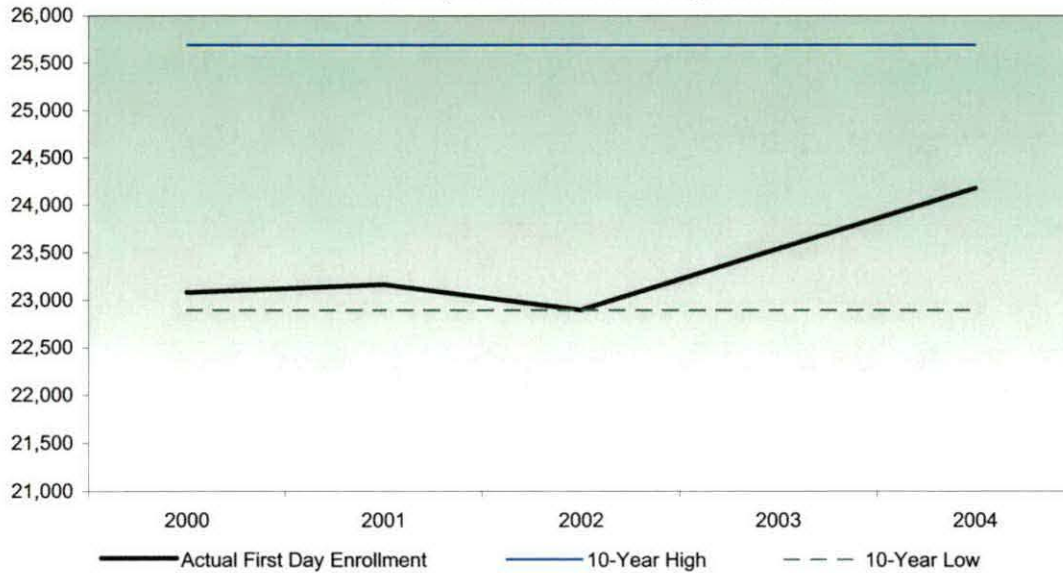

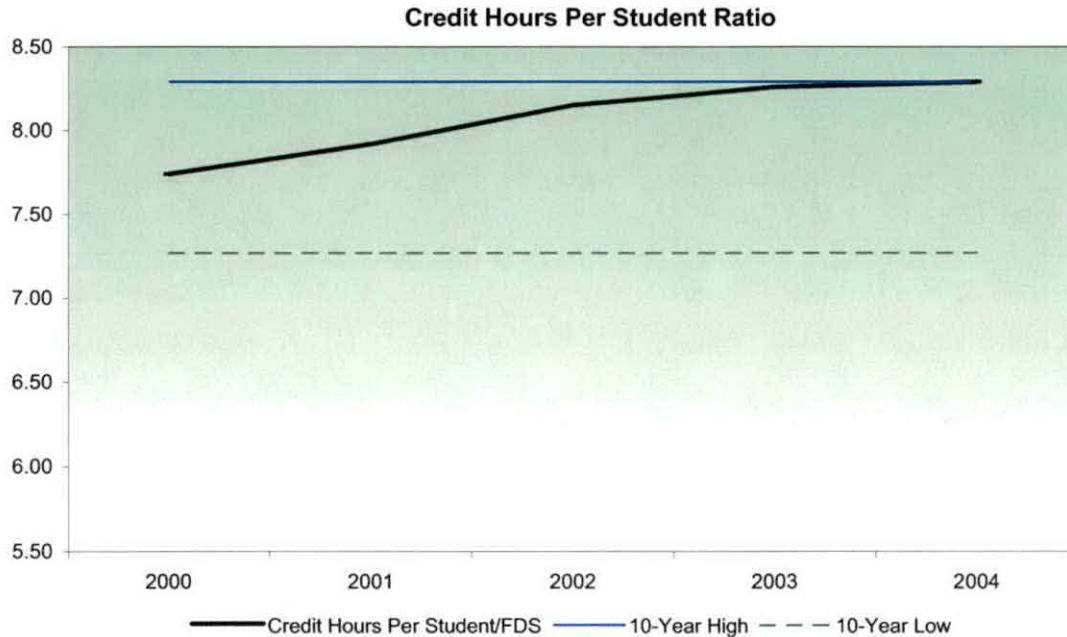

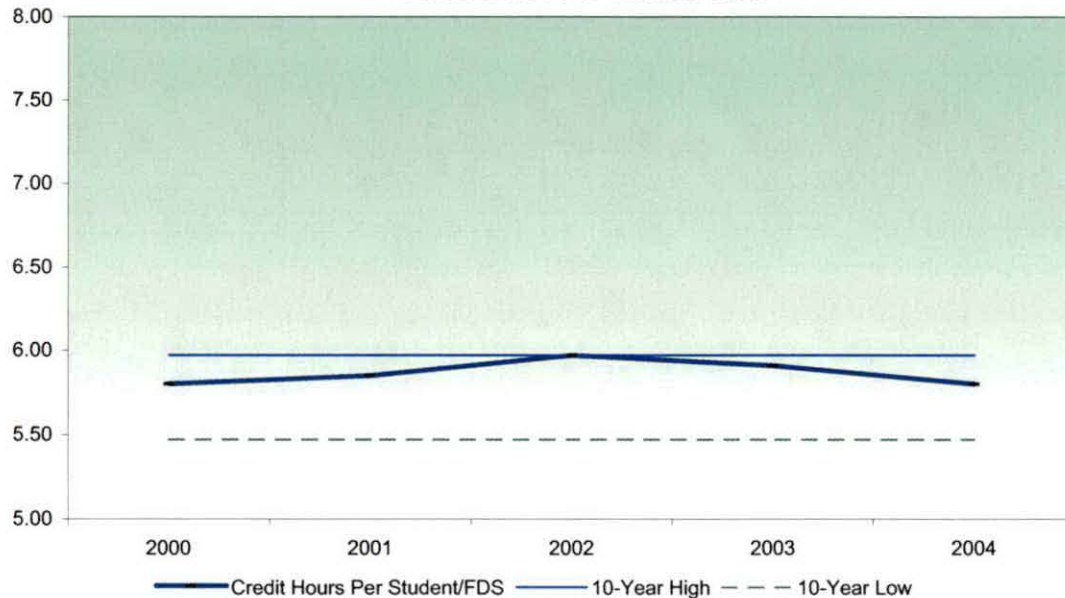

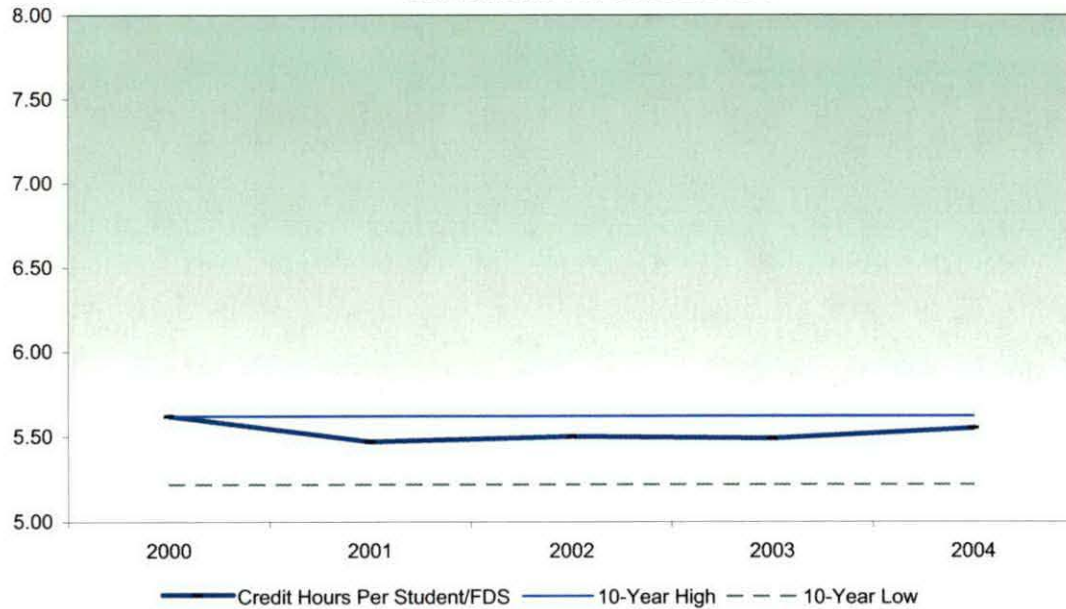

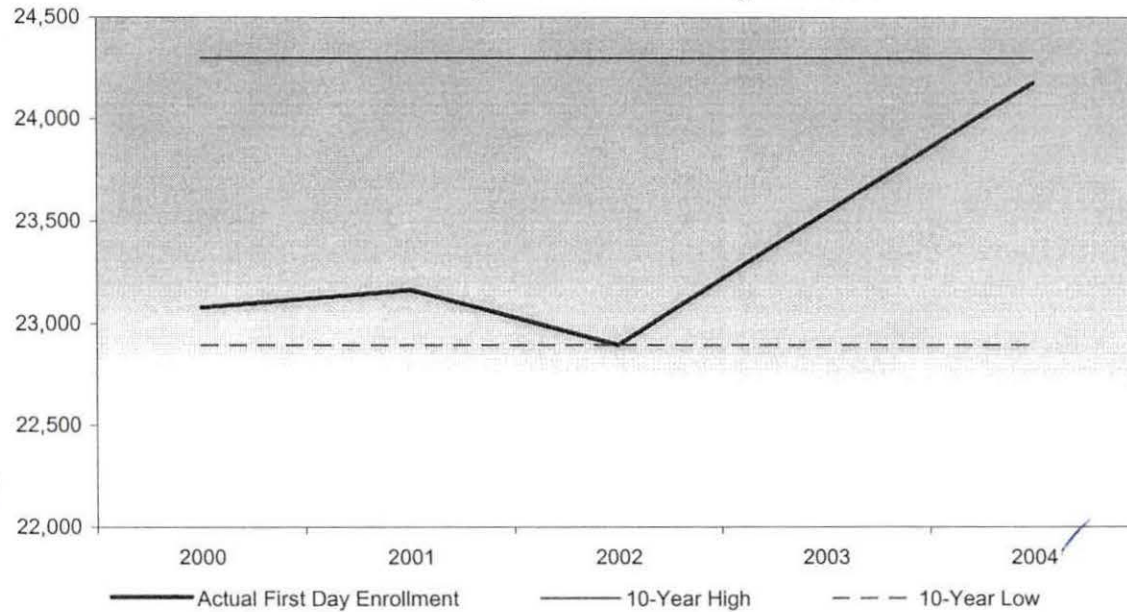

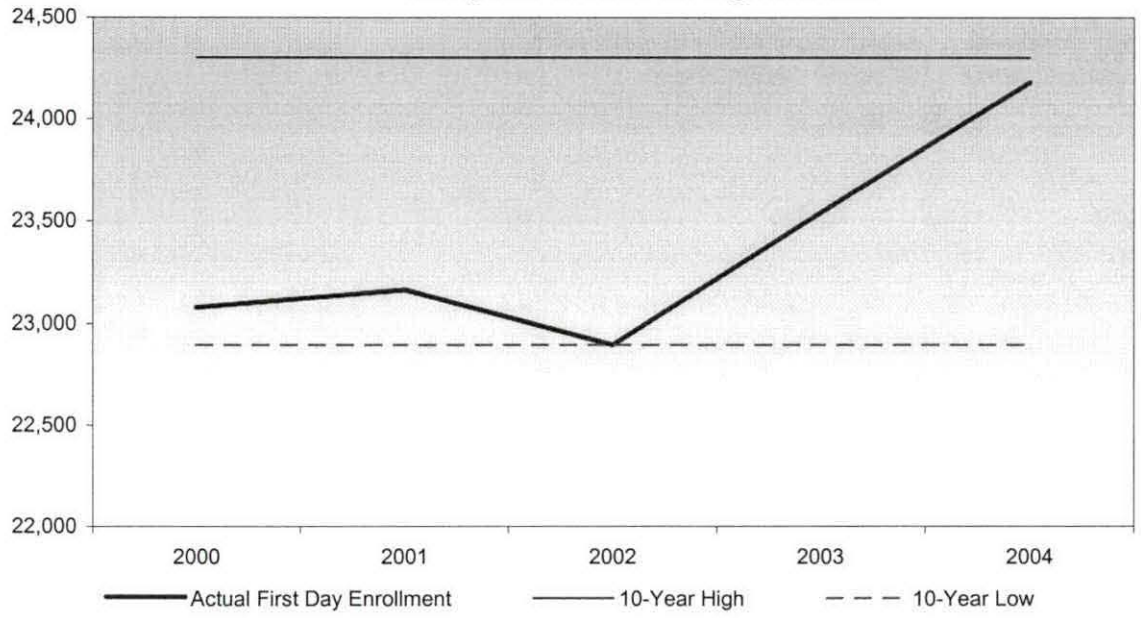

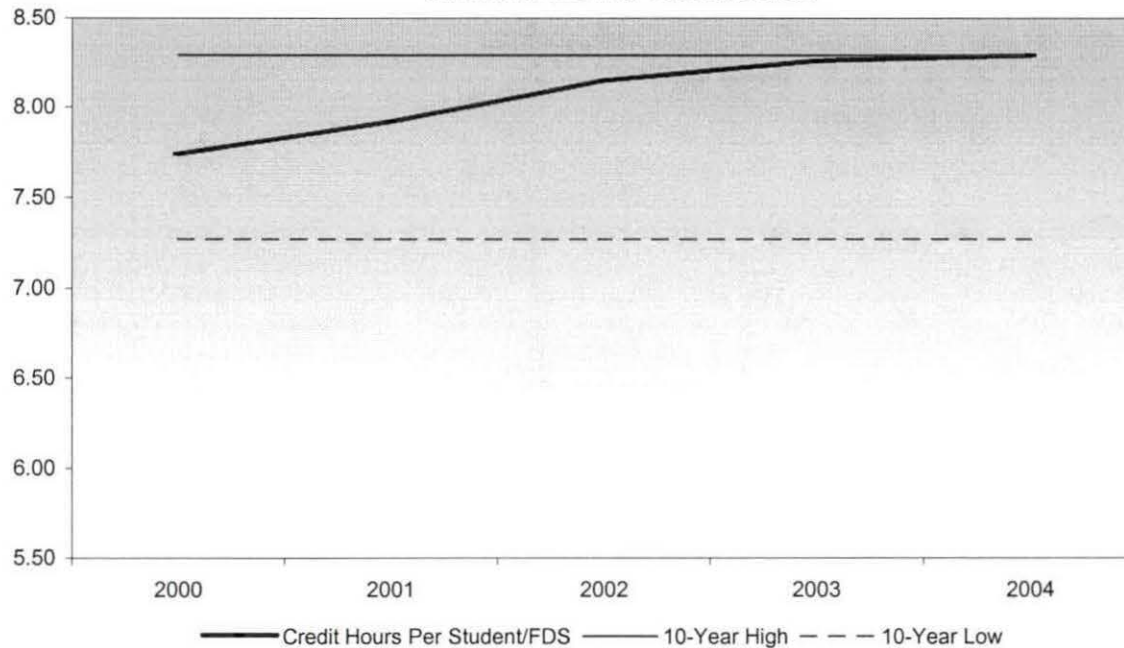

EXECUTIVE SUMMARY**

The following report contains data related to: 1) the number of student credit hours; 2) total student headcount; and 3) the number of credits per student. As a reminder, Institutional Research has added a section to the One-Tenth Day Report that compares College-Wide One-Tenth Day enrollment figures with First Day of Session figures for the same term.

All individual campus Student Credit Hours and Headcounts can be found in the Credits per Student tables.

This report can be summarized with the following main points:

- The number of College-Wide Student Credit Hours has experienced a minor increase of 0.2% when compared with the same time period last year. Over the five-year period (2000 to 2004), total Student Credit Hours increased 9.6%.
- Student Headcount at the college-wide level has increased by 0.6% since 2003, with an increase of 3.8% noted since Fall of 2000.
- College-Wide Credit Hours per Student (8.05) have decreased slightly (-0.5%) since last year. However, over the five-year period, this figure has increased by 5.5%.

Overall, compared to the same figures one year ago, there were increases in College-Wide Student Credit Hours and Headcount, while Credit Hours per Student declined slightly (0.5%). Over the five-year period, however, all three areas increased.

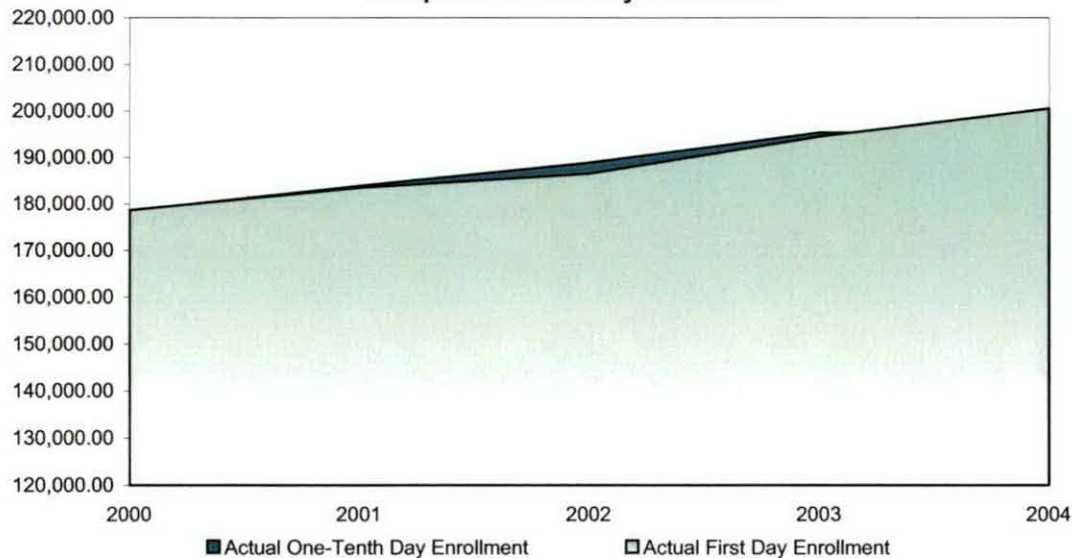

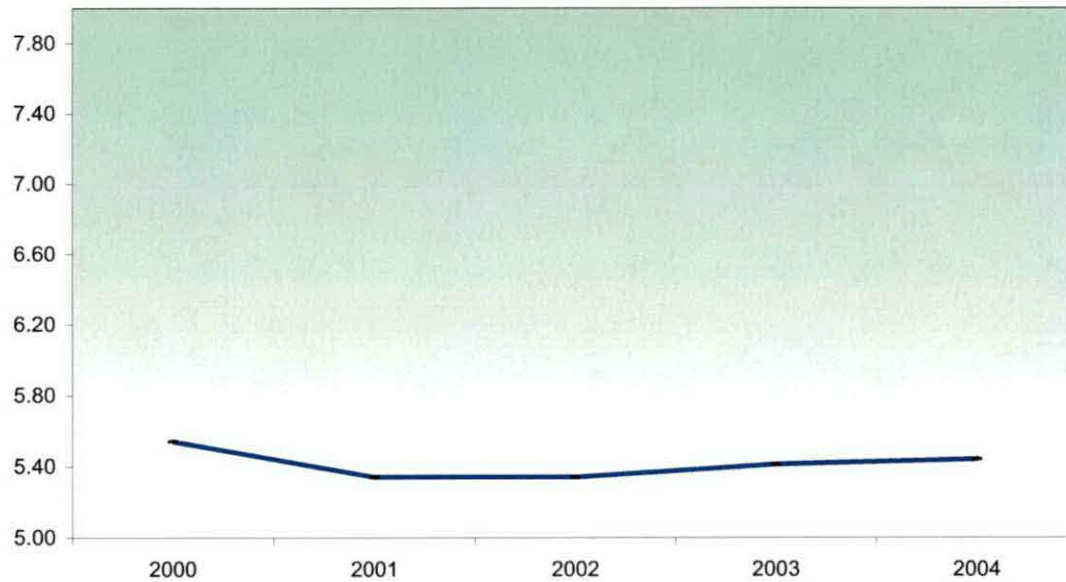

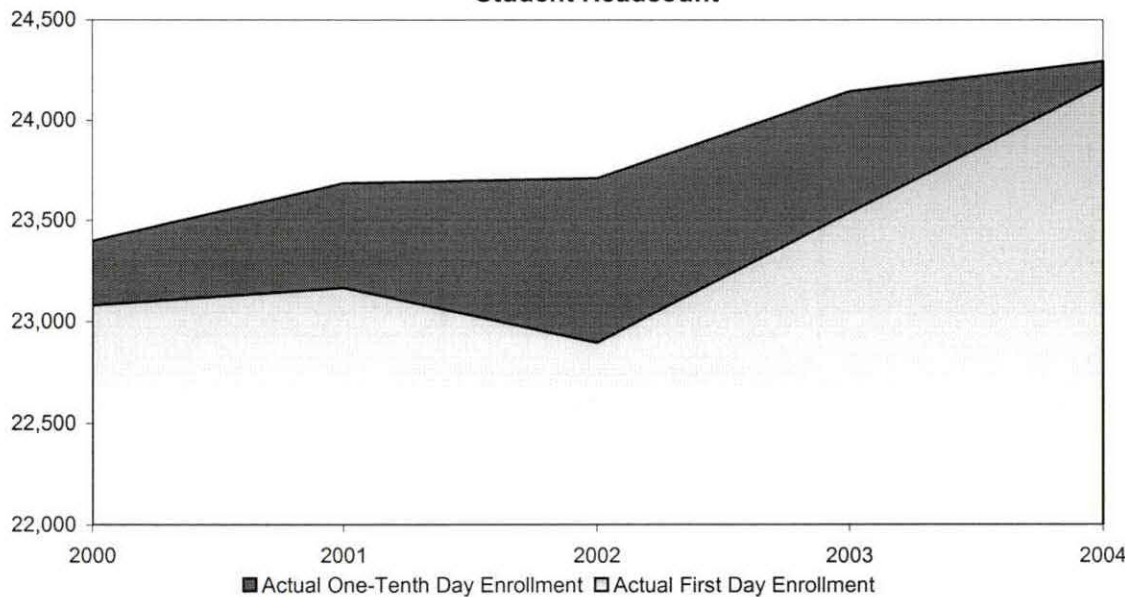

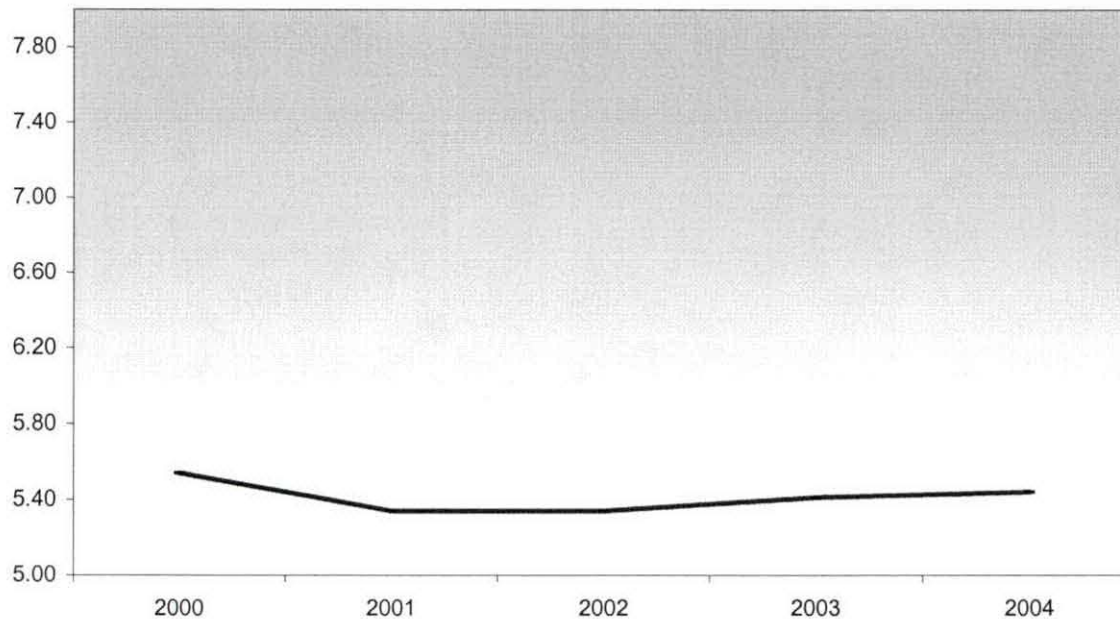

EXECUTIVE SUMMARY**

The following report contains data related to: 1) the number of student credit and non-credit hours; 2) total student headcount; and 3) the number of credit hours per student; as well as projections college-wide and by campus.

All individual campus Student Credit Hours and Headcounts can be found in the Credits Per Student tables.

This report can be summarized with the following main points:

- The combined number of College-Wide Student Credit and Non-Credit Hours has decreased by 2.8% when compared to the same time period one year ago. Over a five-year period (2000-2004), combined Credit and Non-Credit Hours decreased by 8.3%.
- At the College-Wide level, Student Headcount experienced a decrease of 4.3% compared with the same time period last year. A decrease of 15.9% in Student Headcount is noted over the five-year time period.
- Compared with the previous year, College-Wide End of Session Credit Hours per Student increased slightly (1.6%). Further, over the five-year period, there was an increase of 9.1% in Credit Hours per Student.

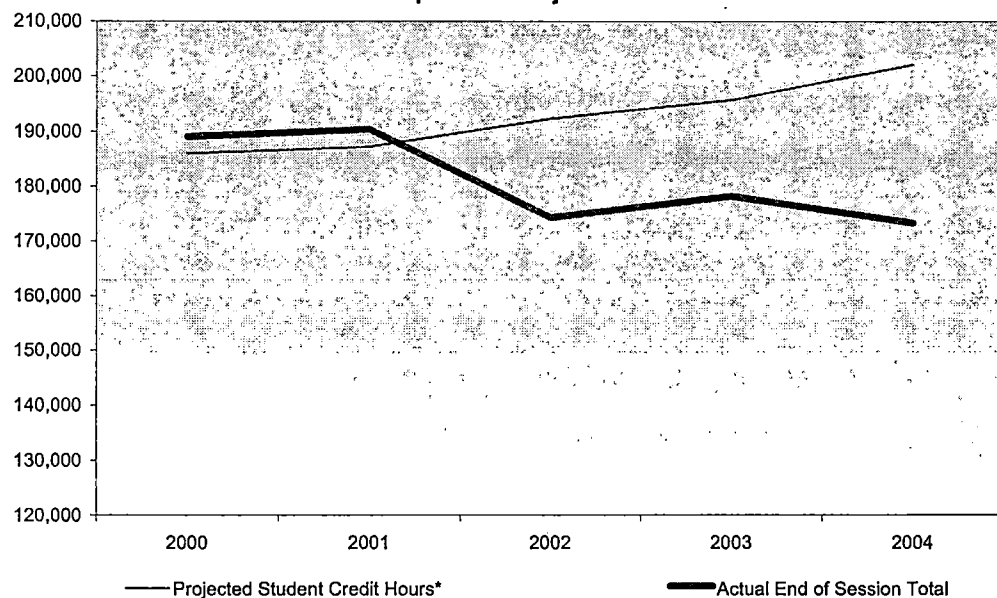
