EXECUTIVE SUMMARY**

The following report contains data related to: 1) the number of student credit hours; 2) total student headcount; and 3) the number of credits per student. As a reminder, Institutional Research has added a section indicating high and low enrollment figures for First Day of Session data over the past ten years.

***It is interesting to note that the Winter 2004 First Day of Session College-Wide Student Credit Hours and Headcounts represent the highest totals in the last ten years.***

All individual campus Student Credit Hours and Headcounts can be found in the Credits per Student tables.

This report can be summarized with the following main points:

- The number of College-Wide Student Credit Hours has shown an increase of 12.3% when compared to the same time period last year. In addition, over the five-year period (2000 to 2004) total Student Credit Hours increased 19.7%.
- Similarly, Student Headcount at the college-wide level has increased by 12.3% since 2003, with an increase of 10.2% over the five-year period.
- College-wide, the Credit Hours per Student are 8.05. This figure remains unchanged compared to last year, but represents an 8.5% increase over the five-year time period.

Overall, compared to the same figures one year ago, there were noteworthy increases in Student Credit Hours and Student Headcount. However, the Credit Hours per Student figure remains stable at 8.05 compared to Winter 2003 First Day of Session data.

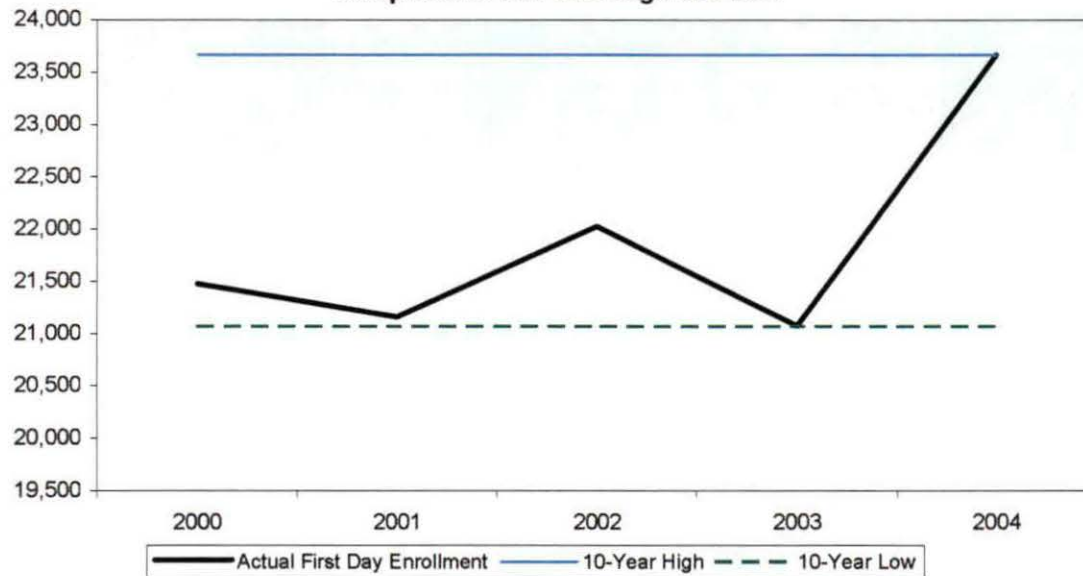

EXECUTIVE SUMMARY**

The following report contains data related to: 1) the number of student credit hours; 2) total student headcount; and 3) the number of credits per student. As a reminder, Institutional Research has added a section to the One-Tenth Day Report that compares College-Wide One-Tenth Day enrollment figures with First Day of Session figures for the same term.

All individual campus Student Credit Hours and Headcounts can be found in the Credits per Student tables.

This report can be summarized with the following main points:

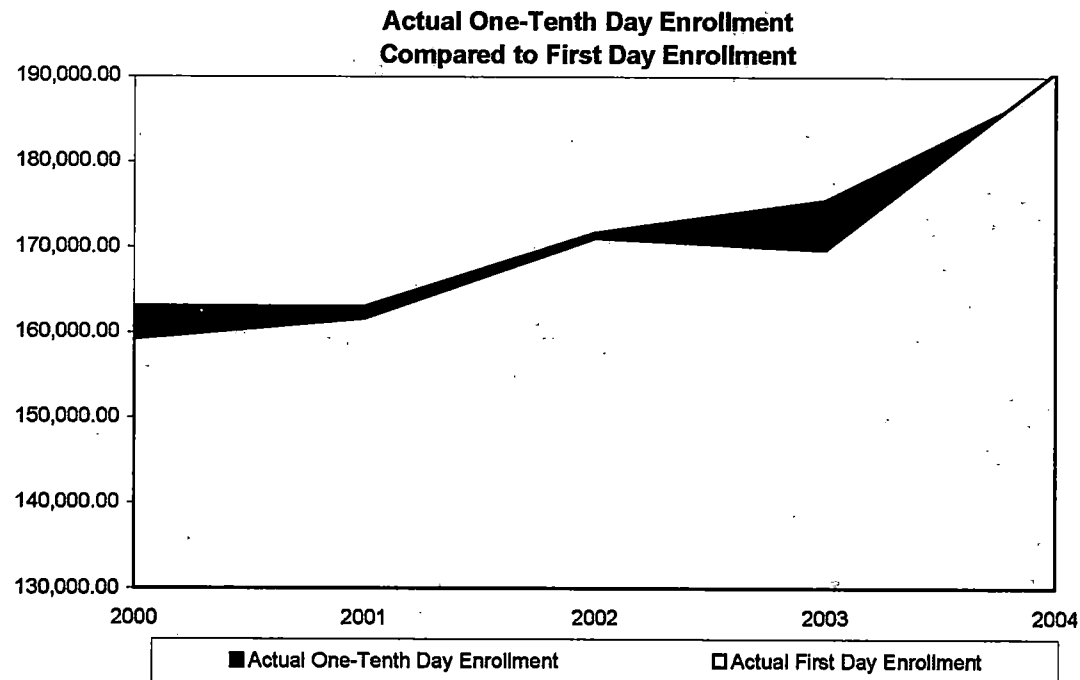
- The number of College-Wide Student Credit Hours has shown an increase of 7.7% when compared with the same time period last year. In addition, over the five-year period (2000 to 2004) total Student Credit Hours increased 15.9%.
- Student Headcount at the college-wide level has increased by 6.7% since 2003, with a similar increase of 7.6% noted over the five-year period.
- College-wide Credit Hours per Student (7.89) have increased slightly (.8%) since last year. However, over the five-year period, this figure has increased by 7.6%.

Overall, compared to the same figures one year ago, there were increases in all areas. While College-Wide Student Credit Hours and Student Headcount each experienced moderate increases (7.7% and 6.7%, respectively), Credit Hours per Student rose only slightly (.8%).

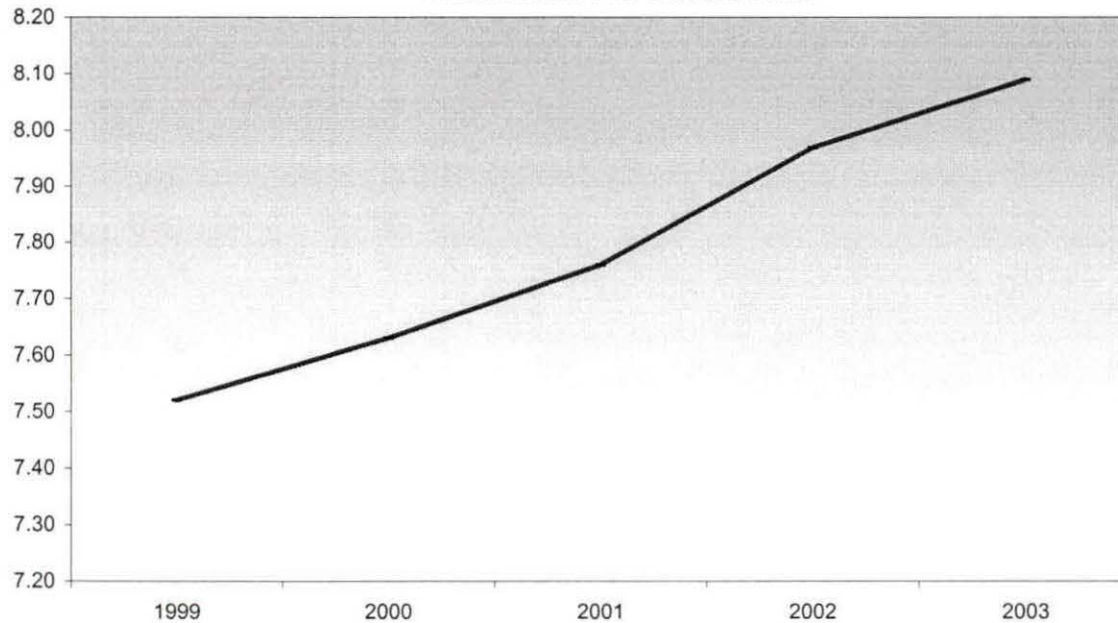

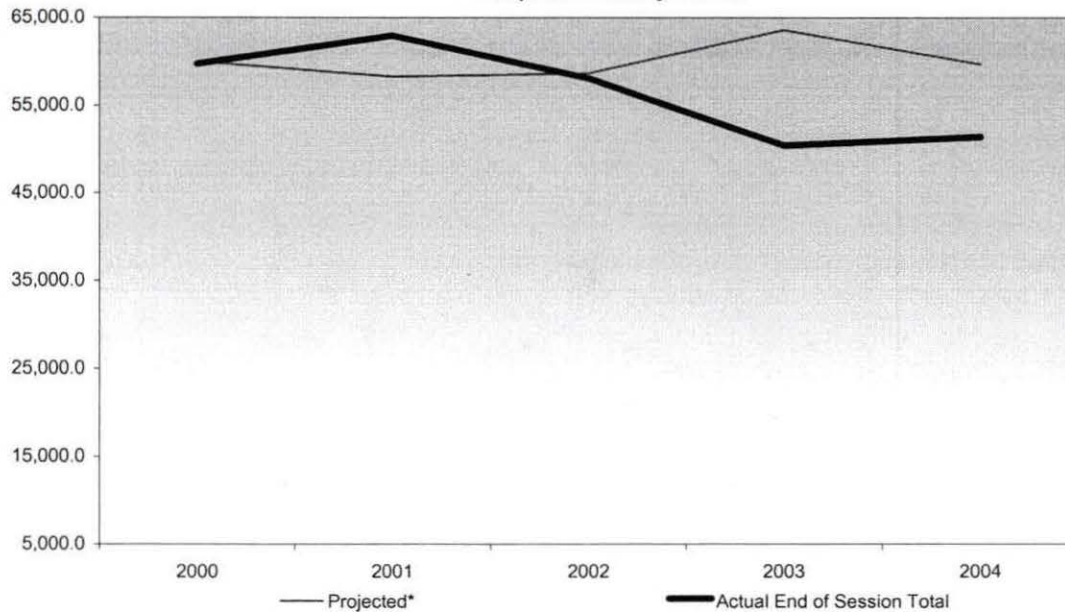

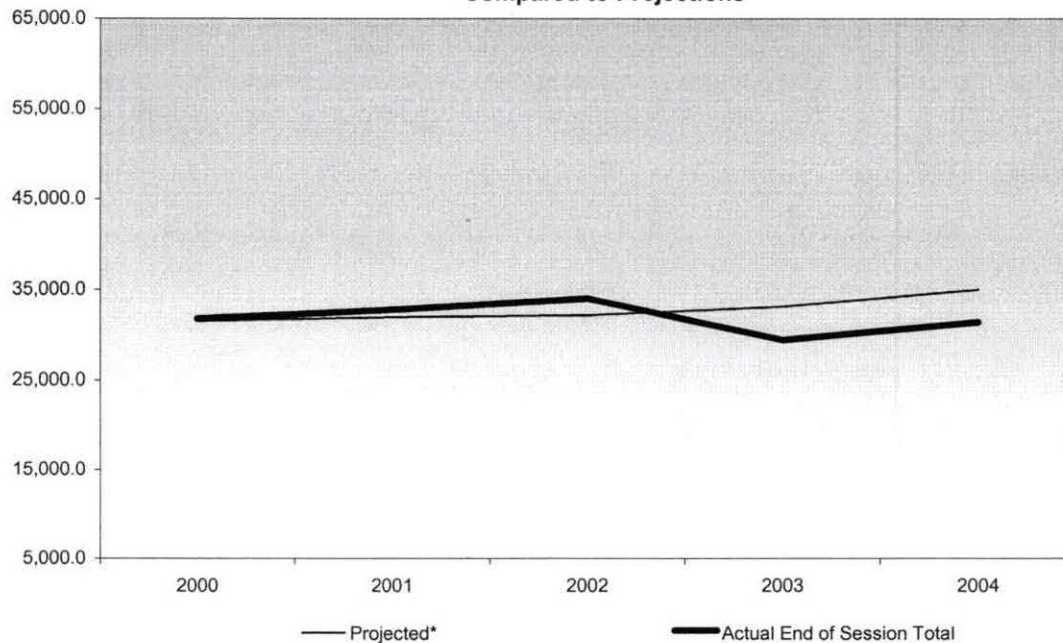
