STUDENT COMPOSITE

The intent of this report is to describe a "typical" Oakland Community College student derived information reported by students on the Admissions Application Form. The composite is derived from the information reported in the Admissions Application for the Fall, 1986, Winter, Spring and Summer, 1987 With the assistance of Mr. Freigruber, Systems Analyst/Institutional Researcher, fourteen (14) variables were analyzed for each student completing the admissions application and enrolling at Oakland Community College at least one of the semesters during the 1986-87 academic year. Students enrolled for more than one semester were used only Again, with the assistance of Mr. Freigruber, composite does not contain duplication of individual student statistics.

The fourteen (14) student variables used for the student composite were: Age, Sex, Ethnicity, Session Applied, Curriculum, Residency, Classification (Freshman/Sophomore), Full-Time/Part-Time, High School, Marital Status, Birth City, High School Graduation Date, Credits Earned, and Cumulative Grade Point Average.

Age--Of the 43,499 students enrolled at OCC during the 1986-87 academic year, 740 students did not provide their age. Of the students who did, the ages ranged from 15 to 87. The most frequent age reported was 20. The Mean Age for 1986-87 was 28.28.

Sex--The majority of students were female, 56.4%.

Ethnicity -- The largest ethnic/racial group was white, / 86.2%.

Curriculum -- Of the 172 curriculum categories reported, the most frequent was the Non-Degree Student, 21.2%. The second most reported curriculum category was Undecided, 15.5%.

during Deturning udents Wint Session Applied--For the students enrolled during the 1986-87 academic year, 22.9% of the students applied for the Fall Semester. For the Winter Semester, 12.1% of these students submitted their application.

Residency Status -- In-district students accounted for 82.5% of the total population.

Classification -- Freshmen comprised 67.1% of the student population.

Full-Time/Part-Time-Of the 43, 499 students enrolled during the 1986-87 academic year, 100% were listed as part-time students. However, due to the collapsing of the variable of student across the four semesters, the full-time/part-time variable is not valid. While a student may have been enrolled on a full-time basis for Fall, 1986, that same student may have been enrolled on a part-time basis for the Winter, 1987 semester.

Birth City--Of the 3,095 birth cities listed, the most frequent city of birth for students was Detroit, 33.4%. The second most frequent city of birth was Pontiac, 13.4%

Year of High School Graduation -- Of the years of high school graduation stated, ranging from 1921 to 1990, the year stated most often was 1985, 8.6%.

Marital Status--Most of the students enrolled during the 1986-87 academic year were single, 71.7%.

Credits Earned--For credits earned, ranging from 0 to 187, 15.5% of the students did not earn any credits while 8.3% earned 3 credits. The mean for credits earned was 21.75.

Cumulative Grade Point Average--Again, 15.5% of the students had a 0.0 GPA, 11.4% earned a 4.0 GPA and 4.4% earned a 3.0 GPA. The mean GPA was 2.54.

High School--Of the 3,610 high schools listed, the most frequent high school from which students, enrolled at OCC during the 1986-87 academic year, graduated from were: Kimball, 2.2%; Pontiac Central, 2.0%; General Education Development (GED), 1.9%; Clarkston, 1.9%; Berkley, 1.8%; Dondero, 1.8%; Waterford Kettering, 1.8%; Rochester, 1.7%; Pontiac Northern, 1.6%; and Waterford Mott, 1.6%.
