## THE LOW COST OF GIVING TO GOD'S WORK AT MICHIGAN CHRISTIAN COLLEGE

<u>Your Taxable Income</u>	<u>Your Monthly Gift</u>	<u>Michigan Tax Credit</u>	<u>U.S. Income Tax Savings</u>	<u>Your Actual Cost</u>
\$ 8,000	\$ 5.00	\$ 2.50	\$1.10	\$1.40
\$12,000	10.00 15.00	5.00 7.50	2.50 3.75	2.50 3.75
\$16,000	20.00 25.00	10.00 11.65	5.60 7.00	4.40 6.35

The above examples are based on Federal tax schedules for married tax payers filing a joint return. The Michigan Tax Credit is limited to the smaller of: 50% of your gift, or 20% of the computed tax, or \$200 on a joint return. We have made the assumption that the gift will qualify for 50% credit. If as a result of the tax credit on the Michigan Income Tax you receive a refund, the refund will be taxable income on your Federal Income Tax return.
